BAC RESOLUTION NO. 2020-059 DECLARATION OF FIRST FAILURE OF THE PROCUREMENT OF APPRECIATION BASKETS OR ITB NO. 2020-0023

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the Procurement of Appreciation Baskets, ITB No. 2020-0023 posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations for the **first time**;

WHEREAS, after the said advertisement was published, only one (1) bidder bought the bidding documents and submitted their bid, namely, **Bloomrich Enterprises**;

WHEREAS, the bid of **Bloomrich Enterprises** was found nonresponsive after submitting an incomplete bid or not indicating any amount in Columns 5, 6, 7 and 8 of the Price Schedule, Goods offered from within the Philippines;

WHEREAS, stated on Section 32.2.1 of RA 9184 and its Implementing Rules and Regulations:

"Xxxx

32.2.1. The BAC shall immediately conduct a detailed evaluation of all bids using non-

discretionary criteria in considering the following:

a) Completeness of the bid. Unless the Instructions to Bidders specifically allow partial bids, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified. In this regard, where a required item is provided, but no price is indicated, the same shall be considered as non-responsive, but specifying a zero (0) or a dash (-) for the said item would mean that it is being offered for free to the Government, except those required by law or regulations to be provided for; and

Xxx″

WHEREAS, a bid will be considered incomplete, non-responsive and automatically disqualified if it does not indicate the bid price in all of the required items in the Bidding Documents.

NOW THEREFORE, we, the members Bids and Awards Committee (BAC), hereby **RESOLVES**, as it is hereby RESOLVED:

- 1) To recommend the declaration of the bidding for a failure for the first; and
- To have a mandatory review of the project's Terms of Reference, Approved Budget for the Contract (ABC) and its Scope of Work, in qccordance with the provisions of Republic Act No. 9184;
