Lease Service Delivery of Eight Megahertz (8MHz - 4 MHz for Distribution and 4 MHz for Contribution)
Standard C-Band Space Segment for the People's Television Network, Inc. (PTNI)

This bulletin is being issued to revise/clarify certain portions of the bidding documents, address a number of concerns and questions. This shall form an integral part of the bidding document for the above-stated project.

Item No.	Comments/Queries/Concerns	Final Response
1	If the JV Partner cannot go to the Philippines to sign-off the JV Agreement and the Special Power of Attorney for authorizing the Partner's Representative to sign the documents, will it be possible that it will only bare e-signs and send it here in the Philippine for notary public?	No, the rules on notarial practice require signatures and not e-signs. See Administrative Matter (AM) No. 02-8-13-SC, Supreme Court of the Philippines, promulgated on 6 July 2004, as amended by AM No. 20-07-04-SC on the 2020 Interim Rules on Remote Notarization of Paper Documents, dated 14 July 2020.
2	Is the Omnibus Sworn Statement must be made in the Philippines before a notary public in the Philippines? Can it be made in Hong Kong before a notary public in Hong Kong? If it can be made in Hong Kong, whether it should be legalized by the Philippine Consulate General in Hong Kong?	An Omnibus Sworn Statement executed in the Philippines must be Notarized in the Philippines. An Omnibus Sworn Statement executed in Hong Kong may be authenticated or legalized in the Philippine Consulate in Hong Kong.
3	What is the meaning of "joint venture" in Class "B" Documents of the Checklist of Technical and Financial Documents? Does it mean an independent corporation to be established by two partners in the Philippines or the cooperation relationship between two partners?	No. It does not mean a new independent corporation is formed.
4	In a JVA, do both partners need to submit PhilGEPS Certificate of Registration?	As stated in Section 23.1, each partner of the joint venture shall submit their respective PhilGEPS Certificates of Registration in accordance with Section 8.5.2 of this IRR.
5	Say a local entity, who has a PhilGEPS Platinum membership will form a JV with a foreign Satellite Service provider, who's a non-PhilGEPS member and doesn't have an existing business here locally, will the legal documents of the local entity suffice and fill the required document of their partner?	No. As stated in No. 8.2.1., concerning joint ventures, each partner of the joint venture must be registered in the PhilGEPS

All other information in the bidding document and issued bid bulletins inconsistent with the above are hereby revised accordingly. All other provisions which are not affected shall remain in effect.
