



BAC RESOLUTION NO. 2019-003 DECLARATION OF POWERCRAFT SOLUTIONS AND DATA INFRASTRUCTURE INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2019-0001

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the Supply, Delivery, Installation, Testing and Commissioning on the Replacements of 36 units 9AH Batteries and Replacements of 2 units Power Modules for 128KVA Symmetra PX UPS at Master Control Room and Technical Operations Center of People's Television Network Inc. (PTNI) or ITB No. 2019-0001 and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, POWERCRAFT SOLUTIONS AND DATA INFRASTRUCTURE INC., bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;

WHEREAS, the Technical Working Group conducted a bid evaluation for POWERCRAFT SOLUTIONS AND DATA INFRASTRUCTURE INC. and whose Single Calculated Bid (SCB) was found to be within the' ABC as follows:
