BAC RESOLUTION NO. 2019-015
DECLARATION OF OLIVEROS PROTECTIVE EQUIPMENT AND MARITIME SUPPLIES
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0003

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the **Supply and Delivery of Sixty-Two (62) Units of 10 Lbs. HFC 236FA and Eighteen (18) Units of 20 Lbs. HFC 236FA Portable Type Fire Extinguisher for the People's Television Network, Inc. (PTNI) or ITB No. 2019-0003** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only two (2) interested bidders bought the bid documents, namely **(1) SUPER NOVA SAFETY PRODUCTS INC.** and **(2) OLIVEROS PROTECTIVE EQUIPMENT AND MARITIME SUPPLIES**;

WHEREAS the two (2) bidders submitted their bids on time and only **OLIVEROS PROTECTIVE EQUIPMENT AND MARITIME SUPPLIES** rated "eligible" or "passed" in the opening of the bids;

WHEREAS, the Technical Working Group conducted a bid evaluation for **OLIVEROS PROTECTIVE EQUIPMENT AND MARITIME SUPPLIES** and whose **Single Calculated Bid (SCB)** was found to be within the ABC as follows:

NOW, THEREFORE, we, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **OLIVEROS PROTECTIVE EQUIPMENT AND MARITIME SUPPLIES** as the Bidder with the Single Calculated and Responsive Bid (SCRB) for the **Supply and Delivery of Sixty-Two**
