

**BAC RESOLUTION NO. 2019-022**  
**DECLARATION OF AGENCE-FRANCE PRESSE**  
**AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)**  
**FOR ITB NO. 2019-0005**

**WHEREAS**, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Provision of International TV News Service** or **ITB No. 2019-0005** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

**WHEREAS**, in response to the said advertisement, only one (1) interested bidder, **AGENCE FRANCE-PRESSE**, bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;

**WHEREAS**, the Technical Working Group conducted a bid evaluation for **AGENCE FRANCE-PRESSE** and whose **Single Calculated Bid (SCB)** was found to be within the ABC as follows:

- a) To declare **AGENCE FRANCE-PRESSE** as the Bidder with the Single Calculated and Responsive Bid (SCRB) for the **Provision of International TV News Service** or **ITB No. 2019-0005**;
- b) To recommend for the approval of the Officer-In-Charge, Network General Manager, PTNI, the foregoing findings, and the issuance of a Notice of Award in favor of said SCR.B.
