

**BAC RESOLUTION NO. 2019-026**  
**DECLARATION OF 90 DEGREES NORTH, INC. AS THE**  
**SECOND LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)**  
**FOR ITB NO. 2019-0010**

**WHEREAS**, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply and Delivery of Transmission Cables, Connectors and Accessories for PTV-11 Cebu Station of People's Television Network Inc. (PTNI)** or **ITB No. 2019-0010** posted the same in the PhilGEPS, Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

**WHEREAS**, in response to the said advertisement, three (3) interested bidders bought the bid documents, namely, **(1) RIMPORT INDUSTRIES INC., (2) 90 DEGREES NORTH, INC.** and **(3) 8BTSI CORP.** and were rated "eligible" or "passed" during the opening of the bids;

**WHEREAS**, the Technical Working Group conducted a bid evaluation for **90 DEGREES NORTH, INC.** and whose **Second Lowest Calculated Bid (LCB)** was found to be within the ABC as follows:

- b) To recommend for the approval of the Head of the Procuring Entity, PTNI, the foregoing findings, and the issuance of a Notice of Award in favor of said LCRB.
