DECLARATION OF COMPOSITE TECHNOLOGY INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0006

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the Supply, Delivery, Installation, Supervision, Integration, Training, Testing and Commissioning of a Technical Broadcast Operation Center (TBOC), Master Control (MC), Playout Automation System, File Based/Base Band Ingest Station, Media Asset Management System (MAMS) and Deep Archive Solutions and Complete Audio/Video/Data System and Operation Workflow of the High Definition Technical Operation Center for the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0006 and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, **COMPOSITE TECHNOLOGY INC.**, bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;

WHEREAS, the Technical Working Group conducted a bid evaluation for **COMPOSITE TECHNOLOGY INC.** and whose **Single Calculated Bid (SCB)** was found to be within the ABC as follows:

- a) To declare **COMPOSITE TECHNOLOGY INC.** as the Bidder with the Single Calculated and Responsive Bid (SCRB) for the **Supply, Delivery, Installation, Supervision, Integration, Training, Testing and Commissioning of a Technical Broadcast Operation Center (TBOC), Master Control (MC), Playout Automation System, File Based/Base Band Ingest Station, Media Asset Management System (MAMS) and Deep Archive Solutions and Complete Audio/Video/Data System and Operation Workflow of the High Definition Technical Operation Center for the Mindanao Media Hub of the People's Television Network, Inc.
