

## BAC RESOLUTION NO. 2019-032 DECLARATION OF BMH SYSTEMS SOLUTION, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2019-0009

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the Supply, Delivery, Installation, Supervision, Integration, Training, Testing and Commissioning of Multipurpose Studio Lighting Facilities for the High Definition Studio of the Mindanao Media Hub of the People's Television Network Inc. (PTNI) or ITB No. 2019-0009 and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, two (2) interested bidders, namely, (1) BMH SYSTEMS SOLUTION, INC. and (2) EVI DISTRIBUTIONS INC. bought the bid documents;

WHEREAS, only BMH SYSTEMS SOLUTION, INC. was rated "passed" or "eligible" during the Opening of Bids, due to the late submission of bids of EVI DISTRIBUTIONS INC.;

WHEREAS, the Technical Working Group conducted a bid evaluation for BMH SYSTEMS SOLUTION, INC. and whose Single Calculated Bid (SCB) was found to be within the ABC as follows:
