BAC RESOLUTION NO. 2019-035
DECLARATION OF RIMPORT INDUSTRIES AS THE
THIRD LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR ITB NO. 2019-0007

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the **Supply, Delivery, Installation, Integration, Training, Testing and Commissioning of Two (2) Portable Sets of Digital Microwave Transmitter Units and Accessories and Two (2) Portable Sets of Digital Microwave Receiver Units and Accessories for the Live Broadcast Link of the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0007** posted the same in the PhilGEPS, Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, **three (3) interested bidders** bought the bid documents, namely, **(1) COMPOSITE TECHNOLOGY, INC., (2) SOLID VIDEO CORPORATION, and (3) RIMPORT INDUSTRIES INC.;**

WHEREAS, the Technical Working Group conducted a bid evaluation and found **COMPOSITE TECHNOLOGY, INC., SOLID VIDEO CORPORATION and RIMPORT INDUSTRIES INC.** to have the **Lowest Calculated Bidder (LCB), Second Lowest Calculated Bidder and Third Lowest Calculated Bidder** respectively which is within the ABC;

WHEREAS, **Rimport Industries, Inc.**, as the **Third Lowest Calculated Bidder**, was subjected to post-qualification by the Technical Working Group immediately after it conducted its bid evaluation;

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Rimport Industries, Inc.**, the **Third Lowest Calculated Bidder**, its bid has been found to be responsive;

NOW, THEREFORE, we, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **RIMPORT INDUSTRIES, INC.** as the Bidder with the **Third Lowest Calculated Bidder (LCRB)** for the **Supply, Delivery, Installation, Integration, Training, Testing and Commissioning of Two (2) Portable Sets of Digital Microwave Transmitter Units and Accessories and Two (2) Portable Sets of Digital Microwave Receiver Units and Accessories for the Live Broadcast Link of the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0007;**
- b) To recommend for the approval of the Head of the Procuring Entity, PTNI, the foregoing findings, and the issuance of a Notice of Award in favor of said LCRB.
