

BAC RESOLUTION NO. 2019-039 DECLARATION OF COMPOSITE TECHNOLOGY, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2019-0013

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the Service Level Agreement for Technical Operation Center and Master Control (TOC/MC), Media Asset Management Systems (MAMS) Deep Archives, Ingest servers, Graphics and News Room Computer System (NRCS) of People's Television Network Inc. Broadcast Facilities and I.T. Infrastructures or ITB No. 2019-0013 posted the same in the PhilGEPS, Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, COMPOSITE TECHNOLOGY, INC., bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;
