

## BAC RESOLUTION NO. 2019-056 DECLARATION OF BLOOMRICH ENTERPRISES AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2019-0031

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the Supply and Delivery of Grocery Items for the Christmas 2019 Giveaways of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0031 and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, Bloomrich Enterprises, bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;
