

BAC RESOLUTION NO. 2019-58
DECLARATION OF SOLID VIDEO CORPORATION AS THE
SECOND LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR ITB NO. 2019-0017

WHEREAS, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply, Delivery, Installation, Testing, Training and Commissioning of Two (2) Sets of Cellular Bonded Transmitters and One (1) Receiver with Complete Standard Accessories using Wireless Live Broadcasting Transmission via Internet for The Live News Coverage Operation of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0017** posted the same in the PhilGEPS, Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, three (3) interested bidders bought the bid documents, namely, **1) BMH Systems Solution, Inc.; 2) Solid Video Corporation; and 3) Composite Technology, Inc.;**

WHEREAS, the Technical Working Group conducted a bid evaluation and ranked the bidders as follows:

WHEREAS, BMH Systems Solution, Inc. was declared an unresponsive bidder due to the submission of expired Platinum PhilGEPS Registration and non-submission of Class "A" Eligibility Documents in lieu of PhilGEPS Registration (refer to GPPB Resolution No. 18-2017) ;

WHEREAS, Solid Video Corporation, as the **Second Lowest Calculated Bidder,** was subjected to post-qualification by the Technical Working Group immediately after it conducted its bid evaluation;

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Solid Video Corporation**, the **Second Lowest Calculated Bidder**, was found to be responsive;

NOW, THEREFORE, we, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **Solid Video Corporation** as the Bidder with the **Second Lowest Calculated Bidder (LCRB)** for the **Supply, Delivery, Installation, Testing, Training and Commissioning of Tw0 (2) Sets of Cellular Bonded Transmitters and One (1) Receiver with Complete Standard Accessories using Wireless Live Broadcasting Transmission via Internet for The Live News Coverage Operation of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0017;**
- b) To recommend for the approval of the Head of the Procuring Entity, PTNI, the foregoing findings, and the issuance of a Notice of Award in favor of said LCRB.
