DECLARATION OF SOLID VIDEO CORPORATION
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0024

WHEREAS, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply, Delivery, Installation, Integration, Training, Testing and Commissioning of a Complete System and Accessories of C-Band Satellite Earth Station of the Mindanao Media Hub of the People's Television Network, Inc. (PTNI)** or **ITB No. 2019-0024** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, **Solid Video Corporation**, bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;
