DECLARATION OF COMPOSITE TECHNOLOGY INC.
AS THE SECOND LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR ITB NO. 2019-0019

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the **Supply, Delivery, Installation, Testing, Training and Commissioning of Three (3) Sets of Cellular Bonded Transmitters and One (1) Receiver with Complete Standard Accessories using Wireless Live Broadcasting Transmission via Internet for The Live News Coverage Operations of the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-00119** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, two (2) interested bidders bought the bid documents, namely, 1) BMH Systems Solution, Inc.; and 2) Composite Technology, Inc.;

WHEREAS, the Technical Working Group conducted a bid evaluation for **COMPOSITE TECHNOLOGY INC.** and whose **Second Lowest Calculated Bid (LCB)** was found to be within the ABC as follows:

WHEREAS, **BMH Systems Solution, Inc.** was declared as non-responsive after submitting an expired PhilGEPS "Platinum" Certification on the Opening of Bids and non-submission of Class "A" Eligibility Documents in lieu of PhilGEPS Registration (refer to GPPB Resolution No. 18-2017);

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **COMPOSITE TECHNOLOGY INC.**, the **Second Lowest Calculated Bidder**, its bid has been found to be responsive;

NOW, THEREFORE, we, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **COMPOSITE TECHNOLOGY INC.** as the Bidder with the Second Lowest Calculated and Responsive Bid (LCRB) for the **Supply, Delivery, Installation, Testing, Training and Commissioning of Three (3) Sets of Cellular Bonded Transmitters and One (1) Set of Receiver with Complete Standard Accessories using Wireless Live Broadcasting Transmission Via Internet for the Live News Coverage Operations for the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0019;**
- b) To recommend for the approval of the Head of the Procuring Entity (HoPE), the foregoing findings, and the issuance of a Notice of Award in favor of said LCRB.
