DECLARATION OF PHILIPPINE GLOBAL COMMUNICATIONS INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0029

WHEREAS, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply, Delivery, Integration, Installation, Training and Commissioning of a 2-Core Dark Fiber Optic Cable Dedicated Transmission Link from PCSO Lotto Shaw Blvd. Mandaluyong to PTV Main Station in Quezon City with Active Back up and Diverse Route for Seamless High Quality Connectivity, Including the End-to-End Terminal Equipment with Accessories** or **ITB No. 2019-0029** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, **Philippine Global Communications Inc.**, bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;

WHEREAS, the Technical Working Group conducted a bid evaluation for **Philippine Global Communications Inc.** and whose **Single Calculated Bid (SCB)** was found to be within the ABC as follows:

- b) To recommend for the approval of the Network General Manager, PTNI, the foregoing findings, and the issuance of a Notice of Award in favor of said SCRB.


