BAC RESOLUTION NO. 2020-002
DECLARATION OF TRI-EX TOWER COMPANY INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0015

WHEREAS, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply, Delivery, Retrofitting Including Lightning and grounding System of PTV Cordillera (PTV-8 Baguio) TV Broadcast Tower for The Provincial Station of the People's Television Network, Inc. (PTNI)** or **ITB No. 2019-0015** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder, **Tri-Ex Tower Company Inc.**, bought the bid documents and was rated "passed" or "eligible" during the Opening of Bids;

WHEREAS, the Technical Working Group conducted a bid evaluation for **Tri-Ex Tower Company Inc.** and whose **Single Calculated Bid (SCB)** was found to be within the ABC as follows:

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Tri-Ex Tower Company Inc.**, the **Single Calculated Bidder**, its bid has been found to be responsive;

(PTNI)** or **ITB No. 2019-0015**;
- b) To recommend for the approval of the Network General Manager, PTNI, the foregoing findings, and the issuance of a Notice of Award in favor of said SCR.B.
