BAC RESOLUTION NO. 2020-004
DECLARATION OF COMPOSITE TECHNOLOGY INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0020

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the **Supply, Delivery, installation, Testing, Supervision, Integration, Training and Commissioning of One Unit of Single Channel Motion Graphics for the Mindanao Media Hub of the People's Television Network, INC. (PTNI) or ITB No. 2019-0020** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, two (2) interested bidders bought the bid documents, namely **(1) BHM Systems Solution, Inc.;** and **(2) Composite Technology, Inc.;**

WHEREAS the two (2) bidders submitted its bids on time and was rated "eligible" or "passed" in the opening of the bids;

WHEREAS, upon careful evaluation of all eligibility, technical and financial requirements submitted by **BMH Systems Solution, Inc.**, it was found to be **non-responsive** after submitting an expired PhilGEPS "Platinum" Certification on the Opening of Bids and non-submission of Class "A" Eligibility Documents in lieu of PhilGEPS Registration (refer to GPPB Resolution No. 18-2017) and proceeded to the next bidder for post-qualification;

WHEREAS, upon careful examination, validation and verification of all eligibility, technical and financial requirements submitted by **Composite Technology, Inc.**, it was found to be responsive;


