BAC RESOLUTION NO. 2020-006
DECLARATION OF BEYOND THE BLUE CORPORATION
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB)
FOR ITB NO. 2019-0028

WHEREAS, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply, Delivery, Integration, Installation, Training and Commissioning of a Complete Digital Audio Processing System with All Necessary Required Accessories for the Completion of Operation as Part of the Studio Audio System for the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0028** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder bought the bid documents, namely **Beyond The Blue Corporation**;

WHEREAS, **Beyond The Blue Corporation** was rated "eligible" or "passed" in the opening of the bids and whose bids were evaluated and ranked as follows;

- b) To recommend for the approval of the Head of the Procuring Entity, the foregoing findings, and the issuance of a Notice of Award in favor of said SCR.B.




