BAC RESOLUTION NO. 2020-009
DECLARATION OF BMH SYSTEMS SOLUTION, INC.
AS THE SECOND LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR ITB NO. 2019-0022

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the **Supply, Delivery, Testing, Training and Commissioning of Seven (7) Units of Electronic News Gathering (ENG) Shoulder Mount and Three (3) Units of Handheld Type Camcorders with Memory Cards and Complete Accessories for the Mindanao Media Hub of the People's Television Network, Inc. (PTNI) or ITB No. 2019-0022** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, two (2) interested bidders bought the bid documents, namely **(1) BMH Systems Solution, Inc.** and **(2) Solid Video Corporation**;

WHEREAS, the two (2) bidders submitted its bids on time and was rated "eligible" or "passed" in the opening of the bids;

WHEREAS, the Technical Working Group conducted a bid evaluation and ranked the bidders as follows:

WHEREAS, the Technical Working Group conducted a bid evaluation and declared **Solid Video Corporation** as the Lowest Calculated Bidder and **BMH Systems Solution, Inc.** as the Second Lowest Calculated Bidder;

WHEREAS, upon careful evaluation of all eligibility, technical and financial requirements submitted by **Solid Video Corporation** was found to have an **unresponsive bid** after not complying to all requirements set by the End-user and proceeded to the post-qualification of the **BMH Systems Solution, Inc.**, the Second Lowest Calculated Bidder;

WHEREAS, after carefully evaluating all eligibility, technical and financial requirements submitted by **BMH Systems Solution, Inc.** was found to have a responsive bid and declared as the Second Lowest Calculated and Responsive Bidder;


NOW, THEREFORE, we, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:
