Waterproofing of Roof deck, Gutter and Third Floor Open Area including Parapet and GI Roof and Rehabilitation of Downspouts for the Main Building of the People's Television Network, Inc. (PTNI)

This bulletin is being issued to revise/clarify certain portions of the bidding documents and address concerns and questions. This shall form an integral part of the bidding document for the above-stated project.

Item No.	Comments/Queries/Concerns	Response
1	Are those bidders from the previous bidding still need to pay for Bidding Documents?	Those who have previously purchased the bidding documents from the last bidding are no longer required to purchase the Bidding documents.
2	With regards to the site inspection, do we need to email for a schedule?	Please see Bid Bulletin No. 1 for the complete details of the Site Inspection.
3	Clarification on the PCAB License category, can it be General Building or Engineering?	The PCAB Category requirement for this project is Specialty for waterproofing work (SP-WP) regardless if you have other PCAB Category.
4	<p>In the project requirement, the PCAB License should have a relative experience which is Specialty for Waterproofing Work (SP-WP) and the minimum License Category is Trade E which the considered size range is Small A.</p> <p>Based on the PCAB board resolution, Small A and Small B contractors without similar experience to bid only for contracts not more than fifty percent (50%) of the allowable range of contract cost of their respective size range(s).</p> <p>What is your take on this? Is the Specialty for Waterproofing Work (SP-WP) still required?</p>	<p>Specialty for Waterproofing Work is still required for this project,</p> <p>RA 9184 states that contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration.</p> <p>Since the contract cost is more than the ARCC, therefore the provision is not applicable.</p>
5	<p>In the last bidding, we encountered a problem with the Technical Documents specifically in Forms.</p> <p>Are you going to provide forms?</p>	<p>You may see the checklist of requirements provided in the Bidding Document.</p> <p>The required form from the last bidding is already removed and corrected.</p>

6	Is there a required form for bidding?	Forms such as - Bid Securing Declaration for Bid Security - Omnibus Sworn Statement - Bid Form for the Procurement of Infrastructure Projects may be download at https://www.gppb.gov.ph/downloadables.php
7	During the Submission and Opening of Bid, can we attend physically?	We are not preventing physical presence but we discourage it, due to safety protocols but if you want to participate physically you may check the guidelines in the bidding documents.

All other information in the bidding document inconsistent with the above is hereby revised accordingly. All other provisions which are not affected shall remain in effect.
