## TERMS OF REFERENCE (TOR)

### Supply & Delivery of Ten (10) Units of Tower Lights for the Transmitter Tower of the PTV Cotabato of the People's Television Network Inc. (PTNI)

#### 1. GENERAL REQUIREMENTS

##### 1.1. Delivery Site

The equipment must be delivered to:

- 1.1.1. PTV 8- Cotabato, Don. E. Sero cor. 6<sup>th</sup> Sts., Rosary Heights, Cotabato City, Maguindanao

##### 1.2. Delivery Period

- 1.2.1. Delivery – Within 30 days from Notice to Proceed

##### 1.3. Price Inclusions

- 1.3.1. Cost of equipment
- 1.3.2. Cost of shipment to the Philippines
- 1.3.3. Cost of brokerage fees
- 1.3.4. 12 % Value Added Tax (VAT)

#### 2. SUPPLIER REQUIREMENT

##### 2.1. Legal/Government Permit and Clearances

- 2.1.1. Necessary business permits and clearances including National Tax Clearance Certificate and Company SEC Registration.
- 2.1.2. Accreditation from the National Telecommunications Commission to engage in the supply of radio transceivers and/or broadcast equipment/accessories.

##### 2.2. Supplier/Dealer Track and Technical Records

- 2.2.1. The bidder must be an authorized reseller, dealer or distributor of broadcast and/or IT equipment in the Philippines and must submit a certification as proof.



- 2.2.2. The bidder shall quote for equipment of reputed brand and make.
- 2.2.3. The bidder shall exhibit its capability in providing maintenance support and services at any given time and day for all offered equipment whether thru phone, internet or on site.
- 2.2.4. The offered equipment shall be complete in all respect and any and all items essential for the completeness of the system must be offered even if not mentioned anywhere in the specifications.
- 2.2.5. PTV may assign its own technical personnel to assist the bidder's technical personnel/s during the course of delivery.
- 2.2.6. The bidder may supply equipment with specifications that is equal or even better than the details specified herein.
- 2.2.7. The bidder shall submit the details of make, model and year of manufacture of all the offered items in the bidder's Bill of Materials.
- 2.2.8. The bidder shall exhibit that it has available service unit of the same brand and model or equivalent unit compatible with the system. This is to ensure completeness of the system in case some of the equipment supplied failed to operate or was subjected for repair within the warranty period.
- 2.2.9. The supplier shall guarantee that all supplied items have passed the quality assurance/quality control of the manufacturer. A certification of such shall be enclosed with the supplied goods.



#### 5. WARRANTIES & TECHNICAL SUPPORT

5.1 The supplier shall guarantee that all items supplied are free from manufacturing defects and workmanship for a minimum of one (1) year from the date of final acceptance.

5.2 Any abnormalities in the operation of all supplied items within the above-mentioned warranty period, the bidder should immediately take precautionary measure to correct it. There shall be no repair or replacement of component part/s of the equipment but replacement of the whole equipment. Any associated cost (i.e. shipment, delivery, etc.) in the importation of spare parts during the said warranty period should be to the account of the bidder. Standard published warranties shall apply to any item not identified with the manufacturer's trademark or trade name.

5.3. The supplier should provide customer service engineers/personnel available thru phone or internet at any given time and day.



## 6. TECHNICAL MANUALS

6.1. Technical Manuals should be supplied for all equipment. These manuals shall include installation instructions, set-up procedures, operating instructions, maintenance instructions and troubleshooting procedures. It should also include the parts list which shall indicate the manufacturer part number, circuit designators, description and generic number, component designator and values. The manual should also include easy-to-read block diagrams, circuit schematics and wiring diagrams.
