1. GENERAL REQUIREMENTS

2. SUPPLIER/DEALER ELIGIBILITY REQUIREMENTS

2.1. Legal/Government Permit and Clearances

- 2.1.2. Foreign bidders must submit equivalent documents and/or permits issued by their City/Country if applicable. However, all documents must be authenticated by their respective Philippine Consulate.

- 2.2.1. The bidder must be an authorized reseller, dealer or distributor of air conditioning equipment in the Philippines and must submit a certification as proof.
- 2.2.2. The bidder shall quote for equipment of reputed brand and make.
- 2.2.3. The offered system shall be complete in all respect and any and all items essential for the completeness of the system must be offered even if not mentioned anywhere in the specifications.
- 2.2.4. The bidder may supply a system with specifications that is equal or even better than the details specified herein.
- 2.2.5. The bidder shall also install the equipment properly.
- 2.2.6. The bidder shall submit the details of make, model and year of manufacture of all the offered items Bill of Materials.
- 2.2.7. The bidder shall exhibit that it has available in the bidder's service unit of the same brand and model or equivalent unit compatible with the system. This is to ensure completeness of the system in case some of the equipment supplied failed to operate or was subjected for repair within the warranty period.
- 2.2.8. The supplier shall guarantee that all supplied equipment has passed the quality assurance/quality control of the manufacturer. A certification of such shall be enclosed with the supplied equipment.

5. WARRANTIES & TECHNICAL SUPPORT

- 5.1. The supplier shall guarantee that all items supplied are free from manufacturing defects and workmanship for a minimum of two (2) years from the date of final acceptance.
- 5.2. Any abnormalities in the operation of all supplied items within the above-mentioned warranty period, the bidder should immediately take precautionary measure to correct it. There shall be no repair or replacement of component part/s of the equipment but replacement of the whole equipment. Any associated cost (i.e. shipment, delivery, etc.) in the importation of spare parts during the said warranty period should be to the account of the bidder. Standard published



warranties shall apply to any item not identified with the manufacturer's trademark or trade name.

6. TECHNICAL MANUALS

6.1. Technical Manuals should be supplied for all equipment. These manuals shall include installation instructions, set-up procedures, operating instructions, maintenance instructions and troubleshooting procedures. It should also include the parts list which shall indicate the manufacturer part number, circuit designators, description and generic number, component designator and values. The manual should also include easy-to-read block diagrams, circuit schematics and wiring diagrams.

7. APPROVED BUDGET FOR THE CONTRACT (ABC)

7.1. The Approved Budget for the Contract (ABC) for the Supply, Delivery, and Installation of Airconditioning Equipment for the Provincial Stations of the People's Television Network, Inc. (PTNI) is **Eight Hundred Forty Six Thousand Pesos (P846,000.00)**.
