1	In Bid Data Sheet, ITB Clause 20.2 "None"	"None"
2	In the Technical Requirement Specification, 5. Warranties, "b" b. The obligation under all warranties shall cover all repairs and/or replacements of defective equipment and spare parts. The shipment of repaired or replaced unit/parts to the factory shall be at the cost of the winning bidder.	b. The obligation under all warranties shall cover all repairs and/or replacements of defective equipment and spare parts. The shipment of repaired or replaced unit/parts to the factory shall be at the cost of the winning bidder. Repair means the removal of a defective item/equipment for purposes of fixing and mending, and the installation of a service unit to continue, and to avoid disruption of operation. Repairs on the same defective item/equipment should only be conducted for a maximum of two (2) instances, otherwise, it shall be subject to replacement. Replacement means the removal of a defective item/component which is beyond repair, and the installation of a new item/component with a new serial number, if any. The defective item/component/equipment may be taken by the winning bidder and/or its principal. Such repair and replacement shall be duly documented by the end-user in coordination with the Property Section.
3	In the Technical Specification Requirements, 6. Technical Services and Testing, "c" c. The winning bidder shall submit the training module Seven (7) days before the training day.	c. 1	<p>Under "2. Scope of Work" of Technical Specification Requirements</p> <p>e. During delivery, inspection and all other activities requiring entry on-site, the winning bidder shall adhere to and take into its own account, all requirements of the conduct of these activities, including, but not limited to, COVID-19 protocols of the Procuring Entity, and other related requirements. The winning bidder shall notify the Procuring Entity, thru the Project Management Office (PMO) at least seven (7) calendar days prior to the schedule of delivery.</p>
2	<p>Under "6. Technical Services and Testing" of Technical Specification Requirements</p> <p>d. The commissioning activity shall be conducted in the presence of duly authorized on-site representatives of PTNI. If such commissioning activity is deemed complete, and that duly authorized on-site representatives of PTNI have no further comments and/or objections, the winning bidder, in coordination with the PMO, shall issue a Certificate of Site Completion highlighting the date of completion of the project. This certificate shall be signed by both the on-site representative of the winning bidder and PTNI. The winning bidder shall submit this certificate, along with the signed full project report, which includes, but not limited to, the testing & commissioning module, and training report to the PMO as a requisite for the issuance of the Certificate of Completion and Final Acceptance.</p>

All other information in the Bidding Documents inconsistent with the above is hereby revised accordingly.
All other provisions which are not affected shall remain in effect.
