3	In the Term of Reference, Technical Details (o) "The Bidder shall deploy a technical crew in all PTV transmitter stations in the event of TVRO system re-orientation and shall shoulder all expenses pertaining to the same. The re-orientation of each TVRO system shall not cause broadcast downtime. The Bidder shall provide all necessary back-up systems to avoid the same."	The Bidder shall deploy a technical crew in all PTV stations in the event of TVRO and Uplink Antenna system re-orientation and shall shoulder all expenses pertaining to the same. The re-orientation of each TVRO and the Uplink Antenna system shall not cause broadcast downtime. The Bidder shall provide all necessary back-up systems to avoid the same. The winning bidder may request assistance, as deemed necessary, from PTV technical personnel [maximum of two (2)]. All expenses by PTV's technical personnel, such as, but not limited to, per diem, meals, transportation, accommodation, and related requirements of LGU of destination, shall be shouldered by the winning bidder.
