The bidder shall guarantee that all supplied equipment has passed the quality control (QC) of the manufacturer. Certification of such shall be enclosed with the supplied equipment. May we request that the 2.1.3 and 2.1.5 of the above mention will not be required because the Manufacturer is not providing Certificates.	Item 2.1.3 is retained. The said certification will serve as basis if the bidder is a authorized distributor here in the Philippines In item 2.1.5 is also retained. The certification will serve as basis that all supplied equipment has passed the quality control.
5	Due to the declaration of Enhance Community Quarantine (ECQ) within NCR and leads to the temporary shutdown of our company's operation, may we appeal for the extension of the opening and submission date, if possible after ECQ.
