# Lease Service Delivery of Eight Megahertz (8MHz - 4 MHz for Distribution and 4 MHz for Contribution) Standard C-Band Space Segment for the People's Television Network, Inc. (PTNI) ITB NO. 2021-0007

This bulletin is being issued to revise/clarify certain portions of the bidding documents. This shall form an integral part of the bidding document for the above-stated project.

1	In between 1. General Requirements and 3. Financial under A. Supplier/Dealer Eligibility Requirements of the Terms of Reference There is no "Provision 2"	It is a typographical error. Please be informed that there is no missing provision between 1. General Requirements and 3. Financial under A. Supplier/Dealer Eligibility Requirements of the Terms of Reference.
2	May we request a list of documents that needs to be apostilled	All documents, except PhilGEPS Certificate of Registration (Platinum Membership), to be submitted by the following shall be apostilled: 1. Foreign bidder; or 2. Foreign partner under JVA
3	In the General Requirements "1.6" "In case there will be re-orientation of ground satellite facilities (parabolic antenna) with respect to satellite, the bidder shall perform the activity simultaneously to all receivers and without downtime to the regular live broadcast operation. The Satellite Provider shall shoulder all cost appertaining thereto." As we will use a different Satellite, we will implement dual illumination during the transition period as stated on the Special Conditions. Given that there are unavoidable situations that are beyond our control, such as, travel restrictions, flight availability, etc., May we ask if we can re-orient the ground satellite facilities in a staggered manner with the assurance that PTNI will not experience any downtime? Please refer to the drawing for the proposed workaround.	As indicated in the Terms of Reference, Dual Illumination must be implemented. This is possible, as long as there is an assurance that there will be no downtime throughout the transition period provided that the re-orientation be done within Thirty (30) Calendar Days, otherwise subsequent charges or fees shall be shouldered by the winning bidder.

6	In the General Requirements 1.4. The bidder must own a satellite bandwidth capacity. If not, the bidder should have a Joint Venture Agreement (JVA) with a Satellite Provider who owns a Satellite bandwidth capacity of which the JVA shall exist for the duration of the project.	Request is hereby denied. The winning bidder must own the Satellite bandwidth capacity. If not, the bidder should have a JVA which is under the provision letter "D. Eligible Bidders".
	We would like to kindly request to relax the General requirements 1.4, given Bandwidth capacity are for lease only, also JVA documentation will really take a while to accomplish from Satellite provider end given all the situations we are in with this pandemic. As per our principal they can provide us a Letter of Authorization indicating Direct Technical Support

It is stated in Section 32.2.1 of RA 9184 that the Bidder shall fill in rates and prices for all items of the Goods described in the Schedule of Prices. Bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, Schedule of Prices, shall be considered non-responsive and, thus, automatically disqualified. In this regard, where a required item is provided but is not applicable to the offered items/service, it is recommended to specify zero (0) or a dash (-) in compliance with the above-mentioned provision.

All other information in the Bidding Documents and Bid Bulletins inconsistent with the above is hereby revised accordingly. All other provisions which are not affected shall remain in effect.
