**DECLARATION OF FIRST FAILURE OF THE SUPPLY, DELIVERY, INSTALLATION, INTEGRATION TESTING, TRAINING AND COMMISSIONING OF TWO (2) SETS OF STUDIO TELEPROMPTER SYSTEM WITH COMPLETE ACCESSORIES FOR STUDIO A & B OF PEOPLE'S TELEVISION NETWORK, INC., ITB NO. 2021-0005**

**WHEREAS**, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the **Supply, Delivery, Installation, Integration Testing, Training and Commissioning of Two (2) Sets of Studio Teleprompter System with Complete Accessories for Studio A & B of People's Television Network, Inc., ITB No. 2021-0005** posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations for the **first time**;

**WHEREAS**, after the said advertisement was published, only one (1) bidder bought the bid documents, namely, **BMH Systems Solution, Inc.**;

**WHEREAS**, on the scheduled opening of bids is on **August 11, 2021**, only **BMH Systems Solution, Inc.** submit their bid tender and no other prospective bidders submitted bid tender for this project;

**WHEREAS**, after opening the Financial Document submitted by the bidder, it was found to have offered a bid price exceeding to the approved budget for abovementioned project, thus, the declaration of disqualification of **BMH Systems Solution, Inc.** and the declaration of the first failure of this project;

**NOW THEREFORE**, we, the members Bids and Awards Committee (BAC), hereby **RESOLVES**, as it is hereby RESOLVED:

- 1) To declare the disqualification of **BMH Systems Solution, Inc.**
- 2) To declare the bidding for the a **failure for the first time**;
- 3) To have a mandatory review of the project's Terms of Reference, Approved Budget for the Contract (ABC) and its Scope of Work, in accordance with the provisions of Republic Act No. 9184;
- 4) To direct the BAC Secretariat to cause the re-publication of the Invitation to Bid of the same project with the agreed upon revised, if applicable, ABC, Terms of Reference and Technical Requirements, in accordance with the provisions of Republic Act No. 9184;
