BAC RESOLUTION NO. 2021-024
DECLARATION OF DISQUALIFICATION OF NON-RESPONSIVE BID
OF STUDIO84 INC. FOR THE ITB NO. 2021-0006

WHEREAS, the People's Television Network, Inc. (PTNI) advertised the Invitation to Bid for the **Supply, Delivery, Testing, and Commissioning of Post Production Editing Laptops of the People's Television Network, Inc. (PTNI) or ITB NO. 2021-0006** and posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations;

WHEREAS, in response to the said advertisement, only one (1) interested bidder bought the bid document, namely, **Studio84 Inc.** was rated "eligible" or "passed" in the opening of the bids and whose bids were evaluated and ranked as follows;

WHEREAS, the Technical Working Group (TWG) conducted the bid evaluation of the **Studio84 Inc.** and it was found out that the bidder failed to declare the figures and/or a zero (0) or dash (-) in Column 6, 7, and 8 of their submitted form for the **"Goods Offered from within the Philippines"**

Column 6 - Transportation & Insurance & All Other Cost Incidental to Delivery Per Item

Column 7 - Sales & Other Taxes Payable If Contract is Awarded Per Item

Column 8 - Cost Of Incidental Services, If Applicable Per Item;

WHEREAS, Section 32 of the 2016 Implementing Rules and Regulations (IRR) of RA 9184 states that:

"Section 32. Bid Evaluation for the Procurement of Goods and Infrastructure Projects

32.2. For the procurement of Goods and Infrastructure Projects, the BAC shall evaluate the financial component of the bids to determine the Lowest Calculated Bid using the following steps:

32.2.1. The BAC shall immediately conduct a detailed evaluation of all bids using non-discretionary criteria in considering the following:

- a) Completeness of the bid. Unless the Instructions to Bidders specifically allow partial bids, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable,*

bill of quantities, shall be considered non-responsive and, thus, automatically disqualified. In this regard, where a required item is provided, but no price is indicated, the same shall be considered as non-responsive, but specifying a zero (0) or a dash (-) for the said item would mean that it is being offered for free to the Government, except those required by law or regulations to be provided for;"

THEREFORE, we, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE** as it is hereby **RESOLVED**:

- 1) To declare the disqualification of **Studio84 Inc.** after having been found to have submitted a non-responsive bid.
- 2) To immediately inform **Studio84 Inc.** of the decision and await its Motion for Reconsideration, if any, within the time frame provided by law.
- 3) To direct the BAC Secretariat to prepare the necessary documents should the bidding be declared the first failure or should the sole bidder's Motion for Reconsideration be favorably considered.


