2	Due to the shortage of delivery of computers, most of our projects take 90 to 120 days.  With this may we request to extend the delivery period from 45 calendar days to 120 calendar days. 3	What is the existing NPAS?	The existing NPAS is Octopus ver.8

The winning bidder must include the integration of existing graphics to Graphics Hub Server)."  Since the existing Graphic Hub Server is VIZRT, may we ask how can we integrate our offered system when there is no other supplier in the market that can integrate with VIZRT other than VIZRT itself?	Correction, it is Central Graphics Storage, not Graphics Hub Server.  We assume that there will be no compatibility issue with other equipment. This will serve as a "hub or storage" of the finished projects of the graphic artist in any graphics engine.  No integration will be required from the existing graphics system to the system being supplied.
