1	Clarification Page 12, clause 5.3 "5.3 Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to: a. For the procurement of Non-expendable Supplies and Services: The Bidder must have completed a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC." Please clarify, if we can use BSP forex for the conversion from USD to Peso for the services provided under the contract for the evaluation that is the Bidder must have completed a single contract that is similar to this project, equivalent to at least fifty percent (50%) of the ABC and the exchange rate used shall be of when service was started? or exchange rate shall be of when service was completed? or we can mention both for reference?	Kindly provide the conversion rate of the contract price using the exchange rate based on the BSP Forex from the date that the contract has started, then adjust using the PSA's Consumer Price Index (CPI).
2	 Request for the extension of bid submission date We would like to request for the extension of bid submission date by 7 calendar days, the reason are as follows: 1. 	 another week or so to process CLC issued from foreign bank. This delay is beyond control of bidders. 2. There have been some unusual logistic issues related to courier services between Hong Kong and Philippines due to local covid situation and associated workforce, it takes about 5 working days now to deliver the documents depending on the Covid situation. This again is beyond the control of bidders, even through documents get prepared on time it is always very tricky to deliver them on time from Hk to Philippines. 3. To apostille documents in Hong Kong, it normally takes about 5 working days upon getting appointment by government authority. Keeping all these points in consideration, we would like to request honorable BAC for the extension of deadline by 7 working days from 3rd November 2021. 	
3	Requirement of documents to be apostilled as submitted by foreign JV partner Please also clarify, it is mentioned that the documents submitted by foreign bidders that are not in English ONLY shall be translated and apostilled, in accordance with Section 23, Clause 23.2 of the 2016 revised IRR of RA No. 9184	Clarification with regards to the Apostilled Documents: Only the eligibility documents of Foreign JV partners which are not in English must be translated into English and authenticated by the appropriate Philippine foreign establishment or post; For Contracting Parties to the Apostille Convention, the documents shall be authenticated through an apostille by the Competent Authority, except for countries identified by the Department of Foreign Affairs (DFA) that will still require legalization (red ribbon) by the relevant Embassy or Consulate. These documents shall be accompanied by a Sworn Statement in a form prescribed by the GPPB stating that the documents submitted are complete and authentic copies of the original, and all statements and information provided therein are true and correct.
