## **Functions of the Network**

# (Title IV, Section 9 of PTNI charter)

- 1) To serve primarily as a vehicle for the State for purposes of education, science and technology, arts, culture, and sports in order to foster national pride and identity;

Year 2020 literally started with a bang with the unexpected eruption of one of the smallest yet most active volcanoes in the world – Taal. Government quickly responded by providing assistance to communities that have been directly and indirectly affected by the catastrophe; and PTV was there every step of the way through the delivery of timely news on the disaster and recovery efforts to the public.

Still reeling from the Taal Volcano disaster, the country had to face what could be the world's toughest challenge in modern times. The unseen enemy suddenly shut down robust economies and caused chaos and confusion even in the world's most developed countries. International travels were cancelled, schooling was stopped – everything was at a standstill. No amount of preparation and advanced health care system could have geared up the world for COVID-19.

Immediately, the Philippine government buckled down to work to mitigate the effects of the virus. The Presidential Communications Operations Office (PCOO) mobilized its information and communication system and PTV, as its television broadcast component became the face and voice of government in the fight against the disease. Through its main and provincial stations and social media accounts, PTV provided unadulterated news to the anxious and fearful public.

While major parts of the country were placed in Enhanced Community Quarantine, the men and women of PTV braved the situation to deliver news as it happens, where it happens.

In this time of desperation, PTV is the voice of calm and truth. It is the source of accurate public information. This is and will always be the Network's commitment.

Ms. De Castro assumed office on 16 May 2020 at the height of the Network's support of the government's information drive on COVID-19 virus.

# **OPERATIONAL HIGHLIGHTS**

### 1) PROGRAMMING

- For the year 2020, PTV devoted a huge chunk of its airtime to programs that are in fulfillment of its mandate. News, public affairs, public service and support to Presidential and government information projects particularly those that provide accurate news and updates on the COVID-19 got the biggest chunk, or 62% of the Network's airtime.
- Because of the enhanced community quarantine, suspension of face-toface classes in schools and universities and implementation of strict health protocols in NCR and other parts of the country, almost all award-giving bodies ceased operations. Only a handful re-entered the scene and gave away recognitions virtually. PTV was able to submit twenty-seven (27) entries out of the targeted sixty (60) and received nineteen (19) nominations from submissions in 2019.

> The Network aired the following special programs in line with the government's efforts to assist the citizenry in these times.

<u>Public Briefing #LagingHandaPH</u> [Monday to Saturday - 11:00AM – 12:00NN (Original) and 3:00PM – 4:00PM (Replay) Aired beginning 16 March 2020]. The program has become the face and voice of reliable and timely news and public information on the fight against COVID-19. Announcements from government offices on matters pertaining to the pandemic are first aired in Public Briefing. Secretary Andanar and Undersecretary Rocky Ignacio make a formidable team as they seek clarifications from concerned personalities and address queries of the media and the public.

• <u>PRRD Talks to the Nation</u> [As necessary - Aired beginning 12 March 2020]. With the Cabinet secretaries and key people as guests, the President gives regular updates on efforts of government to curb the virus.

- While PTV continued to air its regular television programs, the trials that beset the world necessitated for PTV to produce specials. These productions are in support of government's projects and programs meant to ease the negative effects on the Filipinos of the disasters that came one after the other.
  - <u>Bangis ng Taal</u> [20-24 January 2020]. The Network produced an hourly update on the Taal Volcano eruption. The updates featured government's efforts in helping the communities cope with the disaster.
  - <u>Pagbangon</u> [24 January to 07 February 2020]. The 30-minute talk show hosted by Jules Guiang delved into government programs and projects focusing on the recovery of communities from the volcanic eruption.
  - <u>Battle for Manila Bay (Year 2)</u> [26 January 2020]. A co-production with the Department of Environment and Natural Resources, the special documented the clearing operations at the Manila Bay. It was aired live on 26 January 2020.
  - <u>ALERTO: A COVID-19 Special by Secretary Martin Andanar</u> [14 February to 11 May 2020]. What started as a documentary special to explain the origins of the COVID-19 pandemic, ALERTO transformed into a talk show hosted by PCOO Secretary Martin M. Andanar. The program tackled how government is handling the health crisis.

- The production of PTV's regular public affairs programs was momentarily halted because of the declared community quarantine. After restrictions have been eased and new normal production guidelines were put in place, production and telecast of the following programs were resumed:
  - <u>Digong 8888 Hotline</u> [Fridays, 8:00PM 9:00PM Resumed airing on 22 May 2020]. Launched last 11 July 2019, **DIGONG 8888 HOTLINE** continues to be the Network's flagship regular program. It supports the President's 8888 hotline campaign and is the ultimate public service program.
  - <u>Iskoolmates</u> [Thursdays, 8:00PM 9:00PM Resumed airing on 07 May 2020]. This award-winning program serves as an avenue for intelligent discourse and social awareness set in different schools and universities. The show empowers today's free-thinking individuals with information through a program featuring Pinoy teens voicing their views on matters that impact their lives as active stakeholders of the future.
  - <u>Public Eye</u> [Tuesdays, 8:00PM 9:00PM Resumed airing on 01 December 2020]. This is a weekly documentary-formatted show that features ordinary people with extraordinary stories. The program ventures out from the usual host-driven documentaries. In Public Eye, the subjects do the talking. After all, the best persons to tell these stories are the ones who lived through the experiences themselves. The program airs every Tuesday from 8:00pm to 9:00pm.

#### Its other major endeavors comprise of:

- Monthly-themed video banners for the different social media accounts. Every month, New Media creates short animated videos that highlight the months' theme. This is then uploaded across all PTV Social Media platforms and regional FB pages.
- Thematic and celebratory social cards. Thematic social cards in support of monthly/weekly government celebrations as well as greeting cards for Filipino achievers are posted on Facebook and Twitter.
- Continuous team training and consultation with YouTube. Under the tutelage of a YouTube Strategic Manager, New Media underwent continuous training regarding content creation and harnessing online content to allow the team to further explore the avenues for improvement in our audience reach and experience on YouTube.
- Production of content. Apart from the continuing production of original New Media contents PAK and iDokyu, BAYANi, another original, was introduced at the time of the Taal Volcano eruption. BAYANi are short video contents that highlight "Bayanihan Para sa Bayan". These are based on viral stories on the *bayanihan* spirit of the Filipinos during times of great need.

## 3) THE PTV BRAND - PARA SA BAYAN

The PTV Merchandising and Creatives team, working on the PTV brand *Para sa Bayan*, produced and aired infomercials and plugs to respond to the needs of the communities affected by the Taal Volcano eruption.

- It conceptualized and produced Ashfall Advisory, what to do during and after an ashfall, and a music video on the cooperative spirit seen during the calamity.
- Plugs on the COVID-19 were produced and aired one after the other. Many of these were also broadcast in other networks in support of the government's continuing efforts to mitigate the virus.

- In preparation for the full operation of the Mindanao Media Hub (MMH) in 2021, PTV began the hiring of key personnel and completed the procurement and installation of the following:

  - PCOO Secretary Jose Ruperto Martin M. Andanar wrote the DOF confirming the request for support and prioritization of the DTTB project.
  - Meetings and discussions between PCOO and PTV and the PCOO and PTV with DOF were held.
  - Requirements needed by the DOF and NEDA were completed.
  - PCOO and PTV met with the Embassy of Japan and the Ministry of Internal Affairs and Communications (MIC) to discuss the project. Documents showing the project phases, stations to be established, and amount per phase with detailed expenses were finalized.
  - The MIC provided PTV with the concept note for its comments.

- PCOO and PTV met with the Government of Japan in October regarding the DTTB project.
- The final concept note and project matrix were prepared and submitted. PTV completed all its DOF and NEDA submissions.
- Preparatory technical discussions among GPH agencies for the 10<sup>th</sup> Level Meeting were conducted.
- The MIC sent a Japan Study Team consisting of experts from Nippon Koei Co., Ltd. Nomura Research Institute Singapore Pte. Ltd., and Access Co., Ltd.

### 6) ORGANIZATIONAL DEVELOPMENT

- <u>Reconstitution of Committees</u>. The composition of all CSC-mandated committees and the Network's own were reconstituted in 2020 following the designation of a new Network General Manager.
- Table of Organization. The new management, after thorough study, has taken the track of developing a new Table of Organization (T.O.) that is modern and forward-looking. This T.O. shall adhere to the Joint Memorandum Circular of the CSC and DBM enjoining agencies to regularize contract of service (COS) employees.

An expert was hired to be on top of this project which the Network hopes to finish by 2021.

Corollary to the thrust of the Board of Directors that prioritizes employee welfare and in consonance with the Department of Budget and Management (DBM) Budget Circular No. 2020-01 issued last 24 March 2020, the release of hazard pay for personnel who physically report for work was unanimously approved.

On both 20 February and 05 March 2020 meetings, the Committee invited the Programming Committee Chairperson, Ms. Maria Angela C. Gatan, to present the programming plans of the Network as it prepares for a reboot of program concepts and marketing strategy on contents. Ms. Gatan stressed the following: first, the target market or viewers of the program and, second, the branding of the Network to bring in more and appeal to various clients.

It was proposed that the Network focus on news and public information programming rather than other genres, such as entertainment, as the goal is to be the leading news provider in the country. Ms. Gatan suggested that the first step towards that goal is to provide training to the Network's news staff, anchors, reporters, and other news personnel to further tap into the potential of the people working for the Network. The committee proposed that management take advantage of the classification of the Network as a government-owned and -controlled corporation and a venue where other agencies can promote and provide news and information regarding their programs, sectors, and groups through co-productions, blocktiming, special event primers, plugs, and other media values.

Furthermore, Ms. Gatan informed the Board of the plan to revitalize and revamp the news program of PTNI to be carried out by the new Chairperson of the Committee, Network General Manager Katherine De Castro. She presented to the Board the re-launching of PTNI Programs last 17 June 2020 meeting of the committee.

# The following are the key points of the program re-launching presentation:

- a) To accommodate the proposed news segments and its existing features, PTV's morning show *Bagong Pilipinas*, will have an extended timeslot of two (2) hours, from 6:00AM to 8:00AM.
- b) Every newscast will have its own identity. For instance, *Bagong Pilipinas* featuring morning news stories will be live and interactive with its audience.
- c) *Sentro Balita* news program will be revamped into a public service news program.
- d) The primetime PTV News will become Ulat Bayan.
- e) To veer away from being wrongly labeled as a government propaganda machine, PTV will feature stories on both the pro-government and opposition individuals and groups.
- f) The English newscast *PTNI News Headlines* will be given a catchier title. Program concept will focus on stories that will cater to businessmen and entrepreneurs.

g) *Ulat Bayan Weekend* will now feature new segments highlighting Overseas Filipino Workers (OFW) and will be utilizing the Mobile Journalism which will allow people from different corners of the world to be a reporter. Said idea is an accurate representation of the Network's name "People's Television".

Personnel assignments for the above proposed revamped newscasts will depend on the employees' respective specializations and potentials. This way, productivity and creativity are maximized thereby benefitting the production of the revitalized programs.

The Committee members strongly recommended ideas for content that will spotlight Technical Education and Skills Development Authority's (TESDA) various vocational and livelihood programs. A segment on skills-building such as those about business/entrepreneurship and success stories on micro, small, and medium enterprises (MSMEs) will greatly help empower Filipinos at this critical time.

### **Committee Report:**

To complete the rates of various production services being offered by the Network, such as production of OBB/CBB, crawlers and plugs, outside broadcast coverage, conceptualization among others, the Committee, on 26 June 2020, formulated additional fees and passed Board Resolution No. 2020-041 approving such. The rates were arrived at after taking into consideration the prevailing market situation, private organizations' rental charges and the Network's target audience.

In a subsequent meeting in November, the Operations Revenue Generating Committee proposed a revision of the entire Network Media Rates through Board Resolution No. 2020-056. This was brought about by the COVID-19 pandemic which adversely affected the economy. The television broadcast and advertising sectors were among those which were greatly impacted. The Committee also took into account the differences between government and private service rates.

The Committee also decided on the grant of discounted rates for certain establishments as such will earn substantial additional income for the Network.

#### **Committee Report:**

The Committee mostly focused on discussions on the proposed reorganization of the Network after it was decided that the table of organization approved by the GCG as contained in the 2015 Reorganization Plan will be abandoned. This ruling is contained in Board Resolution No. 2020-061 which also highlights the need to follow the steps and guidelines provided in the Governance Commission for Government Owned and Controlled Corporations (GCG) Memorandum Circular No. 2015-04. Management hired an organizational development team to handle the creation of the most suitable Table of Organization. The Network General Manager and the Board of Directors Human Resource Committee oversee the work of the team.

The organizational development team presented its output to the Committee on 25 November 2020. The Committee members suggested revisions to further improve the table of organization (T.O.) such as merging of certain positions, creation of a Human Resources Management and Development Division separate from the Administrative Division and the designation of an Internal Auditor, among others.

Over-all, the proposed T.O., as of the November 2020 meeting, has eight hundred forty-three (843) plantilla positions and can absorb the present number of contractuals and Contract of Service (COS) employees in compliance with existing directives on regularization.

The Committee instructed management to come up with a strategy or road map to slowly transition to the regularization through 2022. This will

enable the Network to adjust financially and logistically when the reorganization is implemented.

A Change Management Team (CMT) whose functions are provided in the GCG guidelines on reorganization was created and put into action. The same GCG guidelines contain the roles and functions of parties who will be involved in the reorganization process.

In its meeting during the latter part of 2020, the Committee was updated that six (6) out of the thirteen (13) required steps and documentation to apply for reorganization have been accomplished. The completion of the more difficult steps will require the assistance of organizational development experts from the Development Academy of the Philippines.

Target date of completion of the requirements is early 2021.

### **Committee Report:**

In early 2020 the People's Television Employee Association (PTEA) submitted a letter of intent to the Board of Directors to negotiate a new Collective Negotiation Agreement (CNA). The PTEA deemed that the conditions under the last CNA may not be applicable anymore in the current times considering the sudden outbreak of COVID-19. It prompted the Committee to call for a meeting to discuss the proposal of PTEA. After its evaluation, the Board forwarded the proposal to the Office of the Government Corporate Counsel (OGCC) for a review of the legality of the

CNA's proposed conditions. The OGCC immediately reviewed and provided its comment.

In view of the reviews and comments provided by the OGCC, the Committee created the Operations Labor Management Committee through Board Resolution No. 2020-046 to handle negotiations with PTEA. The committee includes Board Labor Management Committee Chairperson Baniqued, Technical Assistant for Legal Affairs Atty. Jason Shaheer H. Salendab, and Technical Assistant for Administrative and Finance Atty. Raymond C. Sanchez.

In a subsequent meeting, Committee Chairperson Baniqued reported that he has agreed with the PTEA President on the establishment of the proposed manner of negotiation, the ground rules for the negotiation, and inclusion of only legally accepted conditions during negotiation. The Committee recommended that a member of the contractual and Contract of Service (COS) personnel be present during negotiations so that their perspective may also be considered. After all, they will benefit from the new CNA too once they are regularized.

Likewise, the over-provision of depreciation for PPE-Office Equipment sub-account in prior and current years totaling P20.305 million resulted in the overstatement of Depreciation Expense (for CY 2020) and Accumulated Depreciation in the amounts of P2.050 million and P20.305 million, respectively, and understated the PPE-Office Equipment sub-account and Accumulated Surplus/Deficit account by P20.305 million and P18.255 million, respectively. Moreover, the non-derecognition of various unserviceable PPE items costing P4.968 million due to non-disposal thereof resulted in the overstatement of the PPE account in the same amount, contrary to Paragraph 82 of IPSAS 17.

We were not able to perform alternative audit procedures to determine if any adjustments to the Cash in Bank and PPE accounts are necessary due to the status of records of the PTNI's Finance and Administrative Divisions.

We conducted our audits in accordance with International Standards of Supreme Audit Institutions (ISSAIs). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the PTNI in accordance with the Revised Code of Conduct and Ethical Standards for the Commission on Audit Officials and Employees (Code of Ethics) together with the ethical requirements that are relevant to our audit of the financial statements in the Philippines, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Emphasis of Matter

We draw attention to Note 8 to financial statements disclosing, that the PTNI received various technical equipment amounting to approximately US\$4 million from the Ministry of Internal Affairs and Communications of Japan in 2010 as part of the latter's objective to promote Japanese Digital Terrestrial Broadcasting standards in the Philippines. These remained unrecorded in the books pending completion of required documents. Our opinion is not modified in respect of this matter.

# Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with IPSASs, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the PTNI's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the PTNI or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the PTNI's financial reporting process.

#### Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISSAI's will always detect a material misstatement when it exists. Misstatement can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISSAI's we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the PTNI's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on PTNI's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the PTNI to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and the significant audit findings, including any significant deficiencies in the internal control that we identify during our audit.

#### **Report on Other Legal and Regulatory Requirements**

Our audit was conducted for the purpose of forming an opinion on the basic financial statements taken as a whole. The supplementary information for the year ended December 31, 2020, required by the Bureau of Internal Revenue as disclosed in Note 28 to the financial statements is presented for purposes of additional analysis and is not a required part of the basic financial statements prepared in accordance with IPSASs. Such supplementary information is the responsibility of management.
