- b. Certificate of Satisfactory Service issued by PTNI.

Price Validity: All price quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.

Deliver: The required number of food packs should be delivered on December 10, 2021 at 4:30 pm for Lot 1 and 1:00 pm for Lot 2.

ACTIVITY FOR THE EMPLOYEES OF THE PEOPLE'S TELEVISION NETWORK, INC**

TERMS OF REFERENCE

I. BACKGROUND

Despite the peculiar times, as a show of its appreciation to the hardwork and commitment of its employees, the management of the People's Television Network, Inc. will hold a year-end thanksgiving activity (annual appreciation party) undertaking.

Through the efforts of the men and women of PTV, the government television network was able to provide prompt and accurate news and public information to the Filipino populace. The show of appreciation is especially important because of the risks faced by the network's employees to continue delivering information through television and its social media platforms.

On December 10, 2021, management has decided to distribute packed meals to its employees as a simple way of expressing its gratitude for their hard work. Hence, a catering services provider for packed meal for the dinner of five-hundred (500) personnel is required. The plan is to hold a hybrid of online and face-to-face activities such as online mass and musical and other performances by employees.

II. REQUIREMENT AND QUALIFICATIONS

1. The catering services provider shall have proven capability and track record on the provision of packed meals with a minimum relevant experience of two (2) years.
2. It must also have the capability, resources and experience in serving packed meals for five-hundred (500) personnel for Lot 1- Dinner and Lot 2 for PM Snack.
3. It must also have the following documentary requirements:
 - PhilGeps registration;
 - Mayor's/Business Permit
 - BIR Certificate of Registration for sole proprietors
 - Latest Income/Business Tax Return
 - Signed Terms of Reference indicating compliances with requirements
4. Must show proof of experience in serving clients numbering five-hundred (500) with similar profile as PTV for the last two (2) years, by submitting a list of past

clients including number of persons served, details of meals served (viands, drinks, dessert, etc.) for all events. (Please see attached Annex A)

III. APPROVED BUDGET FOR THE CONTRACT (ABC)

The ABC for Lot 1 is One Hundred Ninety Thousand Pesos (Php190,000.00) inclusive of all applicable government taxes and service charges.

The ABC for Lot 2 is Sixty Thousand Pesos (Php60,000.00) inclusive of all applicable government taxes and service charges.

Bidder may bid for Lot 1 or Lot 2 only or may bid for both Lots.

IV. SCOPE OF WORK AND SPECIFICATIONS

1. Provision of packed meals consisting of the following:

Lot 1

- a. 3-course meal
 - Pork/Chicken/
 - Beef Fish/Sea Food
- b. Vegetables
- c. Rice
- d. Dessert
- e. Canned or Bottled Soda 325 -350 ml (must be cold/chilled)

Lot 2

- a. Noodles
 - b. Sandwich/Pastries
 - c. Canned or Bottled Soda 325 -350 ml (must be cold/chilled)
2. Be able to produce at least three (3) kinds of menu proposal for PTNI. Proposed menu/s should be attached to the quotation for review.
 3. Food container should be reusable, spill proof and non-toxic. Disposable, sturdy and good quality cutlery and utensils shall be provided by the winning supplier.
 4. A panel consisting of the Network's three (3) Food Committee members, two (2) representatives from the BAC II SVP, two (2) representatives from the Technical Working Group and one (1) observer shall evaluate the proposals based on the following:

Taste and Quality	20%
Combination of Meals Offered	10%
Nutritional Value	10%
Sanitation and Safety	10%
Quality of Food Container and Cutlery/Utensils	10%
Over-all Food Quality	60%

Price/Value for Money

40% (for lowest calculated)
35% (for 2nd lowest
calculated)
30% (for 3rd lowest
calculated) and so on

5. The supplier with the highest score shall be awarded the contract.
6. The proponents will be asked to bring samples of their proposed food. Container and cutlery to be provided must be included in the samples for evaluation and food tasting.
7. The winning bidder must guarantee that it shall supply the same quality and taste of food and container/cutlery served during the judging. Non-compliance of winning bidder with the samples presented (both food taste and quality and container/cutlery) shall be a ground for non-payment.

V. MODE OF PROCUREMENT

The mode of procurement shall be under Small Value Procurement as provided in the revised IRR of RA 9184.

VI. DURATION

The required number of food packs should be delivered on December 10 at 4:30 pm for Lot 1 and 1:00 pm for Lot 2.

VII. PAYMENT SCHEME

Full payment of the contract shall be paid within 15 days after the issuance of the following:

- a. Billing statement by the Service Provider. The billing statement must be provided by the service provider within seven (7) days after complete delivery of packed meals; and
- b. Certificate of Satisfactory Service issued by PTNI
