2	May we request to extend the Delivery Period from Sixty (60) Calendar Days to One Hundred Twenty (120) Calendar Days?	We regret that we cannot grant this request, Delivery period will remain Sixty (60) Calendar Days from the date of receipt of the Notice to Proceed.
3	For the Commercial Drone, do you need a drone pilot certificate? We can include the CAAP license on this.	Since PTV will be the operator, the bidder shall assist the PTV end user to secure a drone pilot certificate and CAAP license. The fees shall be shouldered by the bidder.
4	We would like to clarify under Single Largest Completed Project (SLCC) if you could consider. High-Definition Multipurpose Studio Video System for this?	Not accepted. (To be fair with suppliers specializing in the supply and delivery of Drones and Professional DSLR)
