**BAC RESOLUTION NO. 2022-013**

**DECLARATION OF FIRST FAILURE OF THE SUPPLY, DELIVERY, DESIGN AND BUILD OF A FOUR (4) LEGGED TWO HUNDRED FIFTY (250) FEET TV BROADCAST TOWER INCLUDING THE RENOVATION OF EXISTING TRANSMITTER BUILDING WITH ROOF DECK, PERMANENT ELECTRICITY FACILITIES, GROUNDING AND LIGHTNING PROTECTION SYSTEM WITH SITE DEVELOPMENT; PERIMETER FENCE AND GUARD HOUSE FOR PTV LEGAZPI OF PEOPLE'S TELEVISION NETWORK, INC. (PTNI), ITB NO. 2022-0003**

**WHEREAS**, the **People's Television Network, Inc. (PTNI)** advertised the Invitation to Bid for the ***Supply, Delivery, Design and Build of a Four (4) Legged Two Hundred Fifty (250) Feet TV Broadcast Tower including the Renovation of Existing Transmitter Building with Roof deck, Permanent Electricity Facilities, Grounding and Lightning Protection System with Site Development; Perimeter Fence and Guard House for PTV Legazpi of People's Television Network, Inc. (PTNI), ITB No. 2022-0003*** posted the same in the PhilGEPS and Network's websites and in conspicuous places within the premises of PTNI, in accordance with the rules provided under RA 9184, otherwise known as the Government Procurement Act, and its Revised Implementing Rules and Regulations for the **first time**;

**WHEREAS**, after the said advertisement was published, no bidder bought the bid documents and submitted their bid;

**WHEREAS**, stated on Section 35 of RA 9184 and its Implementing Rules and Regulations:

*"Section 35. Failure of Bidding*

*35.1. The BAC shall declare the bidding a failure when:*

*a) No bids are received;"*

**NOW THEREFORE**, we, the members Bids and Awards Committee (BAC), hereby **RESOLVES**, as it is hereby RESOLVED:

- 1) To declare the bidding for a failure for the first time after receiving no bids; and
- 2) To have a mandatory review of the project's Terms of Reference, Approved Budget for the Contract (ABC) and its Scope of Work, in accordance with the provisions of Republic Act No. 9184;
- 3) To direct the BAC Secretariat to cause the re-publication of the Invitation to Bid of the same project with the agreed upon revised, if applicable, ABC, Terms of Reference and Technical Requirements, in accordance with the provisions of Republic Act No. 9184;
