1	<p>With regards to the <i>"Latest certification from the proper government agencies that it is religiously paying the Social Security System (SSS), Pag-IBIG Fund, and Philhealth Insurance contributions as mandated by the law as well as income taxes (if applicable) of the employee to be assigned at the PTNI issued 30 days before the opening of bids"</i></p> <p>What does <i>"30 days before the opening of bids"</i> mean, is it beyond 30 days or within 30 days?</p>	<p>Revising the provision to <i>"Latest certification from the proper government agencies that it is religiously paying the Social Security System (SSS), Pag-IBIG Fund, and Philhealth Insurance contributions as mandated by the law as well as income taxes (if applicable) of the employee to be assigned at the PTNI issued within 30 days before the opening of bids"</i></p> <p>If the Submission and Opening of Bids is on 16 March 2022, the date of certifications should be within February 14 - March 16, 2022.</p>
2	<p>For <i>"Client Satisfaction Rating/ Certification from at least three (3) government or private agencies with which the contractor has a past or ongoing contract. Should be issued 30 days before the opening of bids."</i></p> <p>What does <i>"30 days before the opening of bids"</i> mean, is it beyond 30 days or within 30 days?</p>	<p>Revising the provision to <i>"Client Satisfaction Rating/ Certification from at least three (3) government or private agencies with which the contractor has a past or ongoing contract. Should be issued within 30 days before the opening of bids."</i></p>
3	<p>With regards to the <i>"Latest certification from the proper government agencies that it is religiously paying the Social Security System (SSS), Pag-IBIG Fund, and Philhealth Insurance contributions as mandated by the law as well as income taxes (if applicable) of the employee to be assigned at the PTNI issued 30 days before the opening of bids"</i></p> <p>Do you consider proof of remittance or official receipt as replacement for the certifications?</p>	<p>No, the bidder shall submit the Certifications.</p>
4	<p>With regards to the Supplies stated in Annex D, Is it a monthly supply?</p>	<p>Yes.</p>

5	<p>With regards to the quantity of Polishing Pad, Is it required to supply ten (10) polishing pads every month?</p>	<p>The contractor shall only supply the ten (10) polishing pads in the first month and may supply at least three (3) pads for the following months.</p> <p>The supplier shall also ensure that all supplies are always equipped with all items including the polishing pads.</p>
6	<p>For the <i>“Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;”</i> Is it required to attach supporting documents?</p>	<p>No need, the bidder shall make sure to enumerate the matrix of “Names of outstanding contracts with other contracting party, i.e., PE or private company allowed by the rules, contract date, period and amount or value; and “kinds of Goods and dates of delivery”.</p> <p>The bidder may use the form in pg. 49 of the bidding documents</p>
7	<p>For the <i>“Conformity with the Technical Specifications, which may include production/delivery schedule, manpower requirements, and/or aftersales/parts,”</i> Is it required to attach supporting documents or just a statement of compliance.</p>	<p>No need to attach supporting documents, just state “Comply” in the <i>“Statement of Compliance”</i> column if you complied with the items in Technical Specifications.</p>
8	<p>How many copies of bid are required?</p>	<p>As stated in “15. Sealing and Marking of Bids” Each Bidder shall submit two (2) (one original and one copy) and an additional electronic copy in USB Flash Drive (Real PDF, Doc or Docx format) of the first and second components of its Bid.</p>
9	<p>In Janitorial Manpower (e) <i>“The contractor shall abide by the deployment of personnel with work hours of eight (8) hours a day, seven (7) days a week from Monday to Sunday in two (2) shifts with the following deployment”</i> For clarification with “seven (7) days a week”, is it only six (6) days? For computation of costing how many days the bidder should use? Is it 10% (Administrative Cost)?</p>	<p>Yes, it is six (6) days only but shall covered seven (7) days a week</p> <p>The bidder shall use 313 days for computation of costing.</p> <p>Yes.</p>

Reminder/ Additional Requirement	
1	This is to reiterate and remind the prospective bidders to comply with the Government Procurement Policy Board (GPPB) Resolution No. 15-2021 dated 14 October 2021 for the updated rules on PhilGEPS Certificate of Platinum Registration and Membership All Platinum Merchants (Bidder) shall be required starting 01 January 2022 to update/renew, re-download and reprint their Platinum Certificate. All Class "A" Eligibility Documents in Annex "A" of PhilGEPS Certificate covered by Section 8.5.2 of the 2016 revised IRR of RA 9184 supporting the veracity, authenticity and validity of the Certificate shall remain current and updated during the opening of bids

All other information in the Bidding Documents inconsistent with the above is hereby revised accordingly. All other provisions which are not affected shall remain in effect.
