7	Do you have a specific form for the Detailed Unit Price Analysis or the form will come from the bidder?	No required specific format.
8	It states that all detailed reports shall be prepared on a Legal-size bond paper on a ring/book bound document.  Does this include technical documents?	No required size for the eligibility documents (Legal, Technical and Financial documents) as long as the document is readable and clear.
9	With regards to the Relevant statements of all on-going, completed, awarded but not yet started design/design and build related contracts, curriculum vitae of key staff, partners or principal officers;  Does this correlate to the personnel who are working on all ongoing contracts that we have?	This is for the key staff, partners or principal officers with relevant design/design and build related on-going, completed, awarded but not yet started contract.

Detailed Reports	Yes the bidder shall submit the Preliminary Conceptual Design Plan and Detailed Reports while As-Built Plans will be submitted during the implementation period.
