1	With regards to "5.7. Winning bidder shall provide a minimum of two (2) telephone lines including telephone set. " Are you strict with Telephone Line only, can you consider mobile?	No, the bidder shall provide a Telephone Lines.
2	For "Complete the delivery, installation and configuration within fifteen (15) calendar days from the receipt of the Notice to Proceed." May we request to extend it to thirty (30) calendar days?	30 Calendar Days (CD) is acceptable
3	With regards to Cables and Accessories What do you mean by "high-end"?	Cables shall be an end-to-end Fiber.
	For the N2N Fiber, is it a "N+1 requirement"? meaning two fiber redundancy?.	The N+1 requirement is to make sure that the service you provide has a backup in your main core.
4	For "The guaranteed Internet bandwidth of 1-Gbps Lease Line Internet with 1-Gbps Committed Information Rate (CIR) is attained during working hours (i.e., 7:00 a.m. to 12:00 a.m.)." Do you require 100% CIR, because there is no 100% CIR in reality?	The Committed Information rates (CIR) plays a vital role in the service that you will be providing to PTNI so it shall not be lower than 95%. This is to give us assurance that the bandwidth will not be congested no matter how loaded or busy the network will be.
5	Where is the Database?	It is on the 2nd Floor of PTNI Main Building.
