Terms of Reference

SERVICE REQUIRED FROM THE INTERNATIONAL TV NEWS SERVICE PROVIDER

News and Sports need a provider of video/materials of international news and sports stories. This provider is sometimes called international video news or international TV news and sports service.


The provider shall:

- Provide PTV with video and/or stories of the day's most important topics including breaking news, sports, business, and politics.
- Give access to PTV to its daily news TV service / servers / programs.
- By satellite or internet, allow/permit/authorize PTV to download , record any news material that PTV may need.
- Allow / permit / authorize PTV to edit the downloaded / recorded news/sports news material (i.e NBA updated / International Cycling Events, Road Race, Extreme Sports like Skateboarding) of the provider.
- Allow / permit / authorize PTV to edit the downloaded/ recorded/ news/sports news material of the provider to suit the production and creative requirements of PTV News and of PTV Sports programs.
- The provider shall provide the required password and/or parameters and/or bisscode and the likes.
- Guarantee that it has the rights to the video and/or program materials that they are to provide to PTV.

PTV requires at least 10 news stories/materials per week and 15 sports stories/materials per week.

The Supplier shall invoice PTV on a monthly basis.

Service provider shall guarantee that PTV is free from any liability arising from copyright and similar infringements or violations that may rise from the use of airing and use of airing and use of materials made available by the supplier.
