D. Mode of Procurement:	Procurement will be conducted in accordance with Sec.53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act 9184, otherwise known as "The Government Procurement Reform Act"
E. Documentary Requirements:	Copies of the following eligibility requirements are also required to be submitted along with your quotation/proposal: <ol style="list-style-type: none"><li>1. Mayor's/Business Permit (2022)</li><li>2. PhilGEPS Registration Number</li><li>3. Income/Business Tax Return (2020-stamped 2021)</li><li>4. Omnibus Sworn Statement (duly notarized)</li></ol> *only the BIR Certificate of Registration shall be submitted in lieu of DTI Registration and Mayor's Permit.

**Only Sealed bids/ or E-mail quotations** from the eligible bidders will be opened and a contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during post qualification.

**Payment:** within 30 calendar days after completion and acceptance.

**Price Validity:** All price quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.

**Delivery Period:** within ninety (90) calendar days from receipt of Notice to Proceed.

## TERMS OF REFERENCE (TOR)

### Supply, Delivery, and Testing of Spare Parts of Power Supply in the Analog Transmitter for the People's Television Network, Inc. (PTNI)

#### A. SUPPLIER/DEALER ELIGIBILITY REQUIREMENTS

##### 1. TECHNICAL

##### 1.1 Track Record Certifications


#### THE SUPPLIER/BIDDER MUST PROVIDE THE FOLLOWING CERTIFICATIONS UPON THE SUBMISSION OF BIDS.

- 1.1.1 A track record of supply, delivery, testing and commissioning of power supply components for analog transmitter for a minimum of THREE (3) years.
- 1.1.2 A certificate of exclusive/distributorship/authorized dealer as proof from the manufacturer.
- 1.1.3 Bidder's SLCC similar to the contract to be bid should be any supply, delivery, testing and commissioning of power supply components for analog transmitter. It should have been completed within the last three (3) years, provided that one of the SLCC submitted must be at least 50% of the ABC.
- 1.1.4 A Certificate of Completion and Final acceptance on previous similar power supply components (spare parts), product and/or system for analog transmitter, supplied and delivered local or abroad.
- 1.1.5 A satisfactory performance certificate from the present clients/end-user/company.
- 1.1.6 Certification from the principal that the provider/bidder is authorized to transact with PTNI.

#### B. Technical Conditions for the *Supply Delivery & Testing of twelve (12) SCR Thyristor Power Packs Spare Parts of 60Kwatts Analog Transmitter*

##### 1. Scope of Work

Supply, Delivery, Testing of twelve (12) SCR Thyristor Power Packs Spare Parts of 60Kwatts Analog Transmitter on-site (QC TX Station).



## 2. Warranties

- 2.1 The supplier shall guarantee that the newly purchased TV Transmitter spare parts supplied, and delivered, are free from defects, and shall issue a warranty for a period of Three (3) months from the date of delivery and final acceptance by PTNI.
- 2.2 The obligation under all warranties shall cover replacements of defective spare parts and the shipment of replacement parts shall be at the cost of the provider/bidder account.

## 3. Technical Services

- 3.1 The spare parts supplied and delivered should be fully tested at the factory before shipment. Test data shall be recorded and supplied.
- 3.2 Actual testing shall be conducted on the spare parts supplied and delivered on site upon receiving. The supplier shall bring all the needed equipment and materials for their testing on site.
- 3.3 The supplier shall include the datasheet of supplied spare parts in the Technical Component envelope.

**NOTE: The above-mentioned eligibility requirements are in addition to the eligibility requirements under R.A. 9184.**

### C. Delivery Period

The supplier shall Supply and Deliver the Twelve (12) SCR Thyristor Power Packs for People's Television Network, Inc. (PTNI Main Office at the Broadcast Complex, Visayas Avenue, Diliman, Quezon City, Philippines, within NINETY (90) days from the issuance of Notice to Proceed.

## *Schedule of Requirements*

The delivery schedule expressed as weeks/months stipulates hereafter a delivery date which is the date of delivery to the project site.
