This bulletin is being issued to revise/clarify certain portions of the bidding documents. This shall form an integral part of the bidding document for the above-stated project.

No.	Comments/Queries/Concerns	Response
1	With regards to the "Sketch/ map of office going to the PTNI"	Revising the provision to: "Sketch map of the bidder's office going to the PTNI"
2	For the "COVID-free certificate vaccination card/ certificate" What does it mean? Is it a Vaccination card and a COVID-19 Test Result?	Negative Rapid Antigen Test (AgT) Result and Vaccination Card.
3	For clarification if only those documents listed under "Additional Required Documents to be submitted during the Opening of Bids" will be submitted on the Opening of Bids?	Yes.
4	About the "Section VII Technical Specification" do we only need to put "Comply" on it?	Yes, this is a requirement for the "Conformity with the Technical Specifications, which may include production/delivery schedule, manpower requirements, and/or aftersales/parts, if applicable;"
5	With regards to the "Current and valid certification/clearance from the proper government agencies such as Social Security System (SSS), Pag-IBIG Fund, and Philhealth Insurance and with three (3) months latest proof of remittances as mandated by the law as well as income taxes (if applicable)" For the SSS and Philhealth certification/clearances, can you give the specific months you required? If the required three (3) months are from Dec 2021, Jan 2022 to Feb 2022 and we have a certification/clearance for the month of December 2021 do we still need to attach the proof of remittances?	The required proof of remittance shall covered from Dec 2021 to Feb 2022. However, if the December 2021 remittance is already covered by the Certification/Clearance, the bidder shall only be required to submit the proof of remittances from the month of Jan-Feb 2022

	If we still don't have a certification/clearance for the Month of Jan-Feb 2022 can we submit proof of remittances instead and attach the Certification for the month of December 2021?	
6	With regards to the "Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid" Do we need to include attachments or this is just a matrix?	No need to include attachments, please follow the recommended format in the bidding documents
7	Are we going to follow the 10% admin fee as per DOLE 174?	Yes. please follow the 10% admin fee.
8	Due to the suspension of Philhealth contribution hike, what percentage are we going to follow?	Please use the current implemented percentage (3.5%) before the suspension
9	For the additional electronic (USB) copy do we need to encrypt it with password?	The bidder may or may not put a password on the USB copy, just make sure to seal it in an envelope.
10	In "Annex D" CLEANING SUPPLIES, TOOLS, AND EQUIPMENT under consumables and supplies p. 37 (Sponge - Combination of Scrubbing pad and foam - regular size) there is no indicated quantity for this Item. May we clarify what will be the quantity for this particular item?	The bidder shall supply 100 pieces of sponge every month.

All other information in the Bidding Documents inconsistent with the above is hereby revised accordingly. All other provisions which are not affected shall remain in effect.
