(PTNI), through its Bids and Awards Committee (BAC), invites interested bidders for the Small Value Procurement of **Supply, Rental, Delivery and Installation of LED Video Wall (for Hatol ng Bayan 2022, The PTV Election Special Coverage)**. The details of the project are as follows:

C. Approved Budget for the Contract (ABC):	Two Hundred Thousand Pesos Only. (Php200,000.00)
D. Mode of Procurement:	Procurement will be conducted in accordance with Sec.53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act 9184, otherwise known as "The Government Procurement Reform Act"
E. Documentary Requirements:	Copies of the following eligibility requirements are also required to be submitted along with your quotation/proposal: <ol style="list-style-type: none"><li>1. Mayor's/Business Permit (2022)</li><li>2. PhilGEPS Registration Number</li><li>3. Income/Business Tax Return (2020-stamped 2021)</li><li>4. Omnibus Sworn Statement (duly notarized)</li></ol> <p>*only the BIR Certificate of Registration shall be submitted in lieu of DTI Registration and Mayor's Permit.</p>

**Only Sealed bids/ or E-mail quotations** from the eligible bidders will be opened and a contract will only be awarded to the Lowest Calculated and Responsive Bidder who was determined as such during post qualification.

**Payment:** within 30 calendar days after completion and acceptance.

**Price Validity:** All price quotations shall be considered as fixed prices and not subject to price escalation during contract implementation.

**Delivery Period:** 08 May 2022 to be used from 09 May – 12 May 2022. Pull out of rental is 13 May 2022.



## TECHNICAL SPECIFICATIONS AND REQUIREMENTS

**PROJECT TITLE:** Supply, Rental, Delivery, and Installation of LED Video Wall for Hatol ng Bayan 2022, the PTV Election Special Coverage

### BACKGROUND:

The News and Public Affairs Division is producing an extensive coverage of the 2022 National and Local Elections titled "Hatol ng Bayan 2022". The PTV Election Special Coverage seeks to attract viewers with a new set design to reflect the creativity and capability of the network. A LED Video Wall incorporated within the set will add more visually and enable us to show the updated election results whilst communicating with the reporters in a live "face to face" set-up.

In line with this, we are requesting to rent the video wall as the People's Television Network doesn't have its own video wall in the JO system.

### A. PURPOSE/OBJECTIVES:

- To be able to show the creativity and capability of the network
- To be able to show the updated election results whilst communicating with the reporters "face to face"

### B. SUPPLIER ELIGIBILITY REQUIREMENTS

#### 1.0 LEGAL DOCUMENTS

##### 1.1 Government Permits and Clearances

- 1.1.1 Necessary government requirements under RA 9184 (such as PhilGEPS Platinum Certificate).

#### 2.0 TECHNICAL ELIGIBILITY REQUIREMENTS

- 2.1 The winning bidder must have a track record of supply delivery of the required equipment for minimum of FIVE (5) years.
- 2.2 The winning bidder should have a certificate of authorized distributorship of its products as proof from the manufacturer and support/services base in the Philippines.
- 2.3 The winning bidder must show Purchase Orders, Contracts of similar items procured within the last three (3) years. The previous POs or contracts shall be at least Fifty (50%) of the approved budget for the items to be bid.



- 2.4 The winning bidder shall guarantee that all supplied equipment has passed the quality control (QC) of the manufacturer. A certification of such shall be presented with the supplied equipment.

### 3.0 GENERAL REQUIREMENTS

#### 3.1 Technical Conditions

- 3.1.1 The bidder shall submit the details of the video wall's make, model, and brand.
- 3.1.2 The bidder shall ensure that all delivered items needed are licensed and authentic.
- 3.1.3 The bidder shall be amenable to the user's enquiries regarding the use of the video wall, should such an opportunity arises.
- 3.1.4 The bidder shall ensure that the panels are working properly, with no "dead" LED lights on each panel.
- 3.1.5 The bidder shall offer equipment that adhere to the following technical requirements and conditions:

3.1.5.1 Video format shall be compatible with the existing video codec and format in PTNI-house codec. High Definition 1920 x 1080i format broadcast quality with Digital Embedded Audio.

3.1.5.2 Work natively with different formats such as ProRes, RED, XAVC, AVCHD, H.264, HEVC.

#### 3.2 Warranties

3.2.1 The obligation under all warranties shall cover all repairs or replacements of defective equipment and accessories. The shipment of repaired or replaced parts to the Procuring Entity shall be at the cost of the winning bidder. Replacement means the removal of a defective item/equipment and the installation of a new item/equipment with a new serial number, if any. Such replacement shall be duly documented by the end-user in coordination with the Property Section.

3.2.2 The winning bidder shall guarantee the availability of spare parts and service for the duration of the rental period.

#### 3.3 Project Completion

The winning bidder shall conduct a commissioning activity in the presence of the on-site end-user/s. If such commissioning activity is deemed complete, and that the on-site end-users have no further comments and/or objections, the winning bidder, in coordination with



certificate shall be signed by both the winning bidder's on-site representative and the on-site end-user/s of PTNI. The winning bidder shall submit this certificate, along with the commissioning module to the PMO for evaluation as a requisite for the issuance of the Certificate of Completion and Final Acceptance.

### 3.4 Technical Support

The winning bidder shall provide service - available for telephone or on-site - within the hours of use to answer questions and provide recommendations for concerns regarding general equipment operation, causes and remedies for equipment failure, equipment maintenance, and other technical concerns that may arise.

### 3.5 Technical Personnel

The winning bidder shall provide at least three (3) personnel to set-up the LED video wall and shall have at least two (2) PTNI personnel with them for both the set-up (ingress), during the event, and the dismantling (egress).

## C. PAYMENT TERMS

*lead* The payment to the winning bidder shall be processed after the issuance of the Certificate of Completion and Final Acceptance. There shall be no partial payments and/or progress billings. All requirements for such payment shall be coordinated by the winning bidder to the Property Section.
