This bulletin is being issued to revise/clarify certain portions of the Invitation to Bid.

**Additional Provision**

A Pre-bid conference will be held on 10 August 2023 after the ocular inspection at the 2nd Floor Property Section Office, 2nd Floor, PTNI Broadcast Complex, Visayas Ave., Diliman, Quezon City to discuss among others the bidding procedure and requirements.

**Revised Provision**

**Payment**

Upon determination of the awardee, the bid bond shall be considered as initial payment and the difference between such payment and the offered bid price shall be paid in the form of cash, cashier's check, or manager's check of a reputable bank within the area where the bidding was held. Full payment shall be made within the next working day from the date of the Notice of Award.

In case of failure of full payment within the prescribed period, the awardee may be penalized through cancellation of the award and forfeiture of the bid bond in favor of the government.

*Matapos ideklara ang award, ang bid bond ay ituturing na paunang bayad at ang natitirang halaga mula sa bid offer ay nararapat na bayaran sa pamamagitan ng cash o di kaya'y cashier's/manager's check mula sa kilalang bangko. Ang kabuuang bayad ay dapat na maibigay sa PTNI hanggang sa sumunod na araw mula sa nakatakdang petsa sa Notice of Award.*

*Kung sakali na hindi mabayaran nang buo ng nanalong bidder ang kabuuang halaga sa itinakdang petsa, maaaring kanselahin ng PTNI ang pag-award, at kukunin nito ang bid bond na naging paunang bayad.*

All other information in the invitation to bid inconsistent with the above is hereby revised accordingly. All other provisions which are not affected shall remain in effect.
