**RECOMMENDING THE AWARD TO
JHANIOR SCRAP TRADING AS THE HIGHEST COMPLYING BIDDER FOR

WHEREAS, the People's Television Network, Inc. (PTNI) through its Disposal Committee advertised and posted the Invitation to Bid for the "**Sale of Unserviceable/Scrap Property through Public Auction, D2023-01**" based on the list of Inventory and Inspection Report of Unserviceable Property (IIRUP) on its website and various conspicuous places;

WHEREAS, on 10 August 2023, the Disposal Committee conducted a Pre-bid Conference which was held at the Property Section Office, 2nd Floor, PTNI Broadcast Complex, Visayas Ave., Diliman, Quezon City to discuss the bidding procedure and requirements;

WHEREAS, after the set deadline of bid submission on 15 August 2023, 10:00 AM, ten (10) interested bidders submitted their bids, namely, (1) DC & E Trading, (2) Rowena's Junkshop, (3) Jhanior Scrap Trading, (4) Veloso Trading, (5) Panthertech Marketing Corp., (6) R.D.E Junkshop, (7) FMJDC Merchandise, (8) Lucky Sun Enterprises, (9) Riclen Junkshop, (10) Gilbert Aboc Trading;

WHEREAS, upon opening and careful examination of the completeness of the bids on 15 August 2023, 10:30 AM, **Jhanior Scrap Trading** was found and announced as the Highest Complying Bidder with a bid amount of **Two Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight Pesos (Php 288,888.00)**;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the Members of the Disposal Committee, hereby **RESOLVE** as it hereby **RESOLVED**;
