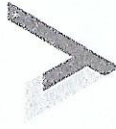

1. Rewinding and Repair of the three (3) units of 25kVA 220V distribution transformers, including the replacement of oil insulator.
2. Supply and Installation of the 200/5 current transformer.
3. Supply and Installation of 20kVA three-phase Automatic Voltage Regulator (AVR), servo type, 220V input, 380V output.
4. Supply and installation of metering, including meter test at local electricity provider (COTELCO).
5. Supply and installation of lightning arrester on Electrical Post for electrical surge protection.
6. Supply and installation of 200A Manual Transfer Switch.
7. Installation of power line service entrance.
8. Installation of new electrical connection including rewiring to service drop.
9. Processing of necessary documents to facilitate reconnection with the local electricity provider

reconnection.

10. Provide an electrical plan.
11. Submit the distribution transformer test duly signed by the engineering of the local power provider.
12. Check and ensure the structural integrity of the electrical post.
