INSTALLATION and COMMISSIONING

Generator Controller:

- 1. Be sure that the parts provided must be the same specification as in the original parts.
- 2. The controller brand / model / program / data must be the same as the Gen Set 1 controller.
- 3. Calibration of program is necessary if needed.

Battery Trickle Charger:

- 1. Battery charger must be fit on the control panel.
- 2. Automatic battery charging must be two stage charging process (first constant current, then constant voltage).
- 3. Suitable for 24volts storage battery and the rated current is 10A.

Scope of Works:

- 1. Installation and commissioning should be done after sign off.
- 2. Must finish the repair as per schedule and don't leave the unit not operational.
- 3. Replace corroded or worn-out electrical field wirings / cables if necessary.
- 4. After all parts have been replaced and installed the generator should be operate in accordance with its original or normal operation.
- 5. In case there are other parts found to be for replace and not included on the terms of reference, it is subject for separate quotation.
- 6. In case the new parts found defective or damaged during the installation, testing, and commissioning within the warranty period, it must replace with a new item.
- 7. Minor repair on other parts must include on the contract.
- 8. Initial start-up and testing.
- 9. Final testing.
- 10. Synchronization.
- 11. Submit certificate of service completion upon completion of service repair installation.
- 12. Full payment upon completion.

Warranty:

> One (1) year warranty on workmanship and supplied items.

Delivery, Installation, Testing, and Commissioning:

- ➤ Delivery of module (order abroad) 30 calendar days upon receipt of Notice to Proceed.
- Installation, testing, and commissioning seven (7) days. Depends on the end-user and engineering given schedule. (Not included on the delivery date of the module).
