### TARGET PARTICIPANTS

This project will cover the procurement of a service provider who shall conduct the RT-PCR tests among the PTNI employees, regardless of employment status by the following circumstances:

- Officers and employees with pre-departure requirement for official travels which require the presentation of negative Covid-19 tests results;
- Officers and employees who will be deployed for official activities such as coverages, attendance to summits, meetings, seminars which requires the presentation of negative COVID19 test results;

## RESPONSIBILITIES OF SERVICE PROVIDER

The service provider shall:

- Be responsible for the storage and supply of testing kits to be used;
- Ensure that the testing kits to be provided are FDA approved and not yet expired;
- Administer nasopharyngeal or oropharyngeal swab (RT PCR) to PTNI officers and employees to determine Covid 19 infection;
- Ensure that in the conduct of tests, the use of personal protective equipment by medical practitioners is observed at all times;
- · Provide materials, medical supplies, and other necessary paraphernalia for the testing;
- Adhere to the guidelines on swab testing set by the Department of Health;
- Responsible for the proper waste disposal of all used materials in the on-site and off-site administration of tests.
- Provide the results of the RT-PCR tests through email to the PTNI focal person within 24 hours or earlier if so required by PTNI;
- Ensure that no other additional fees will be collected to PTNI in the administration of RT-PCR tests;
- Ensure and guarantee that all information, data, test results of the PTNI officers and employees who underwent RT-PCR test shall be kept confidential and secured in accordance with RA 10173 of the Data Privacy Act of 2012.
