



TERMS AND CONDITIONS

1. Awarding of Bids

Award shall be given to the highest complying bidder.

In case of a “Tie” among bidders which takes place when two or more bidders offered exactly the same price quotation, all concerned bidders of their duly authorized representative shall appear after the conduct of the bidding and witness the drawing of lots. This shall be the basis to determine the winning bidders based on sheer luck or chance corollary to the Government Procurement Policy Board (GPPB) Circular No. 06- 2005. The “drawing of lots” shall be conducted by the Disposal Committee in the presence of the concerned bidders on their duly authorized representatives and COA Representative.

Announcement of award should be done immediately after the opening of bids. Bid bonds of losing bidders shall be returned immediately after the announcement of the winning bidder.

Ang award ay ibibigay sa highest complying bidder.

Kung may dalawa o mahigit pang bidder ang nagbigay ng magkakatulad na price quotation, base sa kani-kanilang swerte, magkakaroon ng draw lots ang mga ito na magiging basehan ng pagtukoy ng winning bidder. Ito ay nasasaad sa GPPB Circular No. 06-2005. Ang draw lots ay dapat gawin sa harap ng Disposal Committee at COA Representative.

Ang pagbibigay ng award sa nanalong bidder ay gagawin kaagad pagkatapos ng bid opening.

Ang mga bid bonds ng mga talunang bidder ay agarang ibabalik matapos ang pag-anunsiyo sa nanalong bidder.

2. Payment

Upon determination of the awardee, the bid bond shall be considered as initial payment and the difference between such payment and the offered bid price shall be paid in the form of cash, cashier's check, or manager's check of a reputable bank within the area where the bidding was held. Full payment shall be made within the next working day from the date of the Notice of Award.

In case of failure of full payment within the prescribed period, the awardee may be penalized through cancellation of the award and forfeiture of the bid bond in favor of the government.

Matapos ideklara ang award, ang bid bond ay ituturing na paunang bayad at ang natitirang halaga mula sa bid offer ay nararapat na bayaran sa pamamagitan ng cash o di kaya'y cashier's/manager's check mula sa kilalang bangko. Ang kabuuang bayad ay dapat na maibigay sa PTNI hanggang sa sumunod na araw mula sa nakatakdang petsa sa Notice of Award.



Kung sakali na hindi mabayaran nang buo ng nanalong bidder ang kabuuang halaga sa itinakdang petsa, maaaring kanselahin ng PTNI ang pag-award, at kukunin nito ang bid bond na naging paunang bayad.

3. Hauling of Awarded Items

All expenses incidental to the withdrawal of the property shall be borne by the awardee.

The winning bidder shall be given three (3) working days from 8:00 AM - 5:00 PM upon payment to pull out the unserviceable items awarded subject to the supervision, witnessing, and approval by the concerned Disposal Committee and COA Representative during the actual disposal.

Ang nanalong bidder ang siyang responsable sa lahat ng magiging gastusin sa paghakot ng mga unserviceable/scrap na properties/materials.

Ang nanalong bidder ay mayroon lamang tatlong (3) araw, tuwing 8:00 AM-5:00 PM para hakutin ang mga nasabing properties/materials, kasama ang Disposal Committee at COA Representative.
