1	With the existing generator set, may I ask what is the capacity of the genset? Do we need to install this unit to the new site location?	The capacity of the existing generator set is 75 KVA Single Phase. Yes, the existing generator set shall be installed to PTV Cordillera Broadcast Hub, Romulo Drive, Barangay Lualhati, Baguio City.
2	Do we need to supply a brand new Manual Transfer Switch (MTS)/ Automatic Transfer Switch (ATS)? The reason I asked is because it was not indicated in the TOR/Technical Specification	Yes, a new MTS is required. MTS Specifications MTS Dimensions: 100X340X390 175 A
3	Do you require to physically inspect the site? Is site inspection part of the documentary requirement (Site Inspection Certificate)? If so, what or when is the best time to conduct the inspection?	Please see Annex "A"
4	In the technical specifications, it states that your requirement for the new generator set is in 3 Phase. Then by checking with the existing generator set, it is in single phase. I just wanted to verify which phase is really required, kindly confirm	Yes, the new generator set shall be in three (3) phase.

5	What cables are we going to use, the existing or we need to provide a new one?	The bidder shall provide cables.
