**DECLARATION OF JAKKA SERVICE CENTER CORPORATION AS THE SINGLE**

**WHEREAS**, on 30 August 2023, the Bids and Awards Committee (BAC) conducted the pre-procurement conference of the request for the “Procurement of Various Spare Parts and Services for Motor Vehicles of People’s Television Network, Inc. (Framework Agreement)” where it determined the readiness of the procurement at hand;

**WHEREAS**, the People’s Television Network, Inc. (PTNI) through its BAC advertised the invitation to bid for the said request under ITB No. 2023-0003 through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

**WHEREAS**, on 25 September 2023, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

**WHEREAS**, in response to the said advertisement, only one (1) interested bidder, **Jakka Service Center Corporation**, bought the bidding documents;

**WHEREAS**, on 9 October 2023 at 10:00 am, the secretariat received only one (1) bid from **Jakka Service Center Corporation** and proceeded to the preliminary examination of bid at 10:30 am which was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet

**WHEREAS**, the bid of **Jakka Service Corporated** “passed” and rated for evaluation;

**WHEREAS**, the BAC adopted the observation of the Technical Working Group (TWG) where **Jakka Service Center Corporation** submitted a Single Calculated Bid and provided complete information in their submitted financial component as follows;


