WHEREAS, on 18 October 2023, the Bids and Awards Committee (BAC) conducted the pre-procurement conference of the request for the “Supply and Delivery of Appreciation Baskets for the People’s Television Network, Inc. (PTNI)” where it determined the readiness of the procurement at hand;

WHEREAS, the People’s Television Network, Inc. (PTNI) through its BAC advertised on 24 October 2023 the invitation to bid for the said request under ITB No. 2023-0004 through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 31 October 2023, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, two (2) interested bidder, **(1) Wrap And Carry Supermarket And Department Store** and **(2) Danda Designs And Concepts Inc.**, bought the bidding documents;

WHEREAS, on 13 November 2023 at 10:00 am, the secretariat received two (2) bids from **(1) Wrap And Carry Supermarket And Department Store** and **(2) Danda Designs And Concepts Inc.**, then proceeded to the preliminary examination of bid at 10:30 am which was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet

WHEREAS, both bids of **Wrap And Carry Supermarket And Department Store** and **Danda Designs And Concepts Inc.** “passed” and rated for evaluation;


